A. LVZA 2010-0007 Itinerant Vending

Administrator McGregor presented this item. He asked the Commission for any additional input they had based on the presentation made during the public hearing. Mayor Walker noted that she has missed the prior conversations on this topic, but was wondering how they are going to address door-to-door sales. Commissioner Kahn stated that it would be covered in a separate ordinance and the Commissioners agreed, noting that they had discussed this and decided it was a separate issue. Mayor Walker stated that the Town would have to have some sort of adoption by the Council in order to rely on the Loudoun County Sheriff's Department to enforce the proposed ordinance.

BACKGROUND: The Town Council authorized the Planning Commission and staff to develop recommendations for regulations to control itinerant vending activity. The Planning Commission considered and discussed the issues related to itinerant vending and draft recommendations at their meetings held on April 6, 20 and May 4, 2011. The Commission reached a consensus regarding the draft regulations for itinerant vending at the May 4, 2011 meeting and directed staff to schedule a public hearing. The Commission discussed numerous issues related to itinerant vending, which are summarized as follows:

- 1. The location of such uses. Should they be limited to non-residential land?
- 2. The environmental and traffic impacts of such uses should be mitigated.
- 3. Compliance with state, and local traffic, and health regulations.
- 4. Hours of operation and night lighting.
- 5. Would Christmas tree sales lie within the scope of itinerant vending?
- 6. Whether or not to require permits.
- 7. Whether or not fees should be required, and if so, for non-profit organizations.
- 8. Whether or not permits and fees should be required if an itinerant vendor were to share profits with a non-profit organization (e.g., helping to raise funds).
- 9. Should the property owner be a co-applicant for a permit and responsible for non-compliance if the vendor failed to comply with Ordinance regulations?
- 10. Should the use be required to have sanitary facilities for the employees?

- 11. Should itinerant vending at government-sponsored events be exempt from a permit and a fee?
- 12. Should fireworks sales be allowed?
- 13. Should itinerant vending be allowed at the same time there are outdoor events or activities, such as Oktoberfest, July 3?
- 14. What should the length of duration be for a permit since there are weekend itinerant sales and week long events where itinerant vending occurs?
- 15. There seems to be a need for a different fee structure based on the duration of the permit.
- 16. Can a single permit and fee suffice when there are multiple vendors on a site, or should each vendor be required to have a separate permit?

During the discussion, staff recommended that a new zoning district for private recreation uses be considered in order to allow the current private recreation uses, as well as itinerant vending, on the Lovettsville Game Protective Association (LGPA) property on S. Berlin Pike, which is zoned R-1. This was recommended because the R-1 district does not permit the existing private recreation use. The LGPA operation is a non-conforming use that has been in existence for many years. The Commission concluded that it would be most beneficial for the Town if regulations for itinerant vending were established as soon as possible; creating a new zoning district would be a lengthy process. The Commission also indicated that the staff should involve representatives from the LGPA in the process establishing regulations for itinerant vending along with any discussion of creating a new private recreation zoning district.

PLANNING COMMISSION RECOMMENDATION:

At the conclusion of their discussions the Planning Commission decided to recommend the following Zoning Ordinance regulations for itinerant vending be subject of public hearings:

AMEND: Article 4 GENERAL REGULATIONS, Section 4-14, to read:

"4-14 DATE ARTICLE LAST AMENDED ITINERANT VENDING

Outdoor sales conducted on a temporary basis are classified as itinerant vending and shall be subject to the following requirements:

- (a) Shall be located on non-residentially zoned land and on residentially zoned land on which non-residential uses are developed and active.
- (b) Shall not have an adverse impact on adjacent properties in terms of traffic, lighting, sound, and other environmental nuisances.

- (c) <u>Shall conform to any applicable ordinance regulations in other</u>
 Articles of this Ordinance.
- (d) Shall be subject to applicable federal, state, and local health and sanitation laws.
- (e) Shall be subject to applicable state and local traffic laws.
- (f) A permit is required.
- (g) A permit shall be for 72 consecutive hour increments, except for special events, in which case a permit for seven consecutive days can be obtained. One (1), seven consecutive day permit may be issued per calendar year, per site.
- (h) A permit fee is required in accordance with the Town of Lovettsville Schedule of Fees, except for non-profit organizations.
- (i) <u>No itinerant vending permit is required for government-</u> sponsored events.
- (j) An itinerant vendor who shares any portion of their sales proceeds with a non-profit organization is still required to obtain a permit and pay a permit fee.
- (k) A single permit can include multiple vendors if they are located on a single lot, or contiguous lots in a single ownership.
- (I) If an itinerant vendor does not comply with any applicable standard herein, the property owner of the lot shall be held responsible for compliance.
- (m) Non-compliance by a vendor or property owner shall result in the vendor and the property owner being denied a subsequent permit for a period of six months following the Ordinance violation.
- (n) Fireworks sales are not permitted.
- (o) The Town reserves the right to deny a permit if the sales operation would coincide with a planned outdoor civic activity whenever the Town reasonably concludes that itinerant vending may be expected to interfere with the health, safety and welfare of the participants in the civic activity by reason of proximity of the events, predictable traffic patterns, pedestrian patterns, or demand on personnel providing public safety and emergency response services.

In addition to the draft regulations for itinerant vending, the Commission recommended that the Town Council consider undertaking a study for a new private recreation zoning district, in order to codify and provide regulations for the uses now undertaken on the Lovettsville Game Protective Association property.

The Commission also recommended that the Town Council consider a different fee schedule for permits based on the length of the permit.
