#### Staff Reports

# A. Report from the Zoning Administrator

Manager Markel presented Administrator McGregor's report dated September 3, 2008. He noted that the Sign Committee will meet on September 23<sup>rd</sup>. Council member Dockum asked for additional information about the letter that was sent to all businesses concerning internally lighted signs. Manager Markel reported that enforcement will begin in the coming weeks and noted that this restriction has been Town Ordinance for many, many years. Council member Senate stated that the new ordinance will probably not allow neon or internally lit signs either, although LED signs will probably be allowed. Council member Efthim said that he finds a lit open sign is a public service. Council member Staley said some led lights project very far and Council member Senate stated that this depends on the lens that is used. Council member Zoldos asked if the stop light at the pizza parlor would fall under this ordinance and both Council member Senate and Manager Markel stated that it would probably be considered a decoration.

#### B. Report from the Town Attorney

Attorney Whiting reported that she has distributed an announcement of training sessions being hosted by Leesburg on September 24<sup>th</sup>. FOIA and records management are two of the topics to be covered.

#### C. Report from the Town Manager

Manager Markel reported on the following:

- Progress is being made in the DEQ Consent Order and on the permit renewal and he hopes that this
  will be resolved shortly.
- The bike path agreement has been reviewed by Attorney Whiting, Town Staff and VDOT and it appears that all parties are in agreement.
- He has been evaluating using the generator the Mayor obtained along with other options. The Town is hoping to partner with Loudoun Wireless on other generator sites.
- The on site inspection by KCI of the water tower was done last week and the report should be available in the next few weeks.
- New street lights are being installed, including ten new sites. These will all be the newer down lights.
- Council member Dockum asked how the Town fared when Hurricane Hannah came through and Manager Markel reported that we did very well. We were in high flow on Saturday but by 9 AM Sunday we were in normal flow this is a very, very good result that is probably due to the manhole repair work that has already been done. Mayor Walker added that she was very glad to hear that report from Loudoun Water and she knows the repair work to the manholes had a lot to do with the good result.

Manager Markel stated that there was no new information to present. Mayor Walker said that the next step is to ask for their scope and projected costs.

# C. Request for Study - PC Role in By-Right Development Approvals

Manager Markel explained that this would allow Administrator McGregor to begin researching items that are administrative rather than planning in nature without Planning Commission involvement. Council member Dockum expressed concern that all of the Council was not present at the work session during which this was discussed. Council tabled this item until the October work session. Attorney Whiting expressed her significant concern that the regulatory material is ambiguous in many places and that there would be confusion as to why different projects were being considered under different processes. She prefers that these discrepancies be addressed first in a manner similar to what Administrator McGregor has already done on home occupations. Council member Dockum asked that Administrator McGregor be asked to roughly estimate how many hours would be involved.

#### D. Request for Study – Uses in Residential Districts

Manager Markel explained that this project will allow the Town to express its will concerning appropriate uses in residential districts.

residential zoning districts and bring a report to the Planning Commission for their review and

recommendation.

# E. FY 2008 Donation to Lovettsville Volunteer Fire and Rescue Company

Motion: That the remainder of the balance in the line item 'Donations' in the FY 2008 budget be allocated as the

Town's annual donation to the Lovettsville Fire and Rescue Company

Mayor Walker called for discussion. Council member Efthim believed that the Council had already closed the Fiscal Year 2008 budget and carried all remaining balances forward to 2009. Manager Markel confirmed that the balances had rolled forward but stated that no money had been donated to LVFR in fiscal 2008. He stated that a separate line item will be created for this item in next year's budget. Council member Efthim asked if the allocation would appear in this year's financial statements or if last year's expenditures would be revised. It was agreed that this should be brought to the auditors before a decision was made. Council member Zoldos withdrew his motion and Council member Staley agreed.

### Information Items

Manager Markel queried the Council as to their preferences in scheduling the Streetscape issue. Council member Dockum stated that the proposal should clearly state that this is a conceptual plan and that the data on the Loudoun County GIS system is not entirely accurate and therefore not the best basis for surveying or engineering. Attorney Whiting stated that the plan must go through Planning Commission and there must be public hearings before it can become an official Town Comprehensive Plan. The recommended procedure is for Town Council to become comfortable with the concepts and recommendations and then refer it to the Planning Commission for the official process. Mayor Walker pointed out that the Town must spend the grant money before June 2009. Council member Efthim suggested that the Town could proceed with the engineering work for the limited section we are certain will be approved while the Town proceeds to review the Comprehensive Plan separately. Council member Senate stated that the plan is very vague, but the hard engineering must be done. Manager Markel stated that there is no immediate action required and Mayor Walker asked Attorney Whiting for a

recommendation on how the Town must proceed legally. Manager Markel noted that the current proposed plan does not accurately represent where the property lines are or what the engineers will develop.

# **Comments from the Mayor and Town Council**

Council member Dockum reminded the Council that we will need staffing at the Town booth during Oktoberfest.

Council member Zoldos reported that the Cub Scouts will again be collecting trash at Oktoberfest. He reported that he had attended Movie Night in Middletown and said that they do it very, very well. He has brought back a lot of ideas from that event for Lovettsville's movie night.

Council member Staley asked if Town residents would still be required to purchase decals and was told that they would. He also asked for any progress on relocating the Spring House and was told there was nothing new to report.

Council member Senate reported that on Back to School night Loudoun Street was changed to a one lane street because of on-street parking congestion and it was extremely dangerous. He suggested that in the future the Town arrange for parking at the Lovettsville fire house and run a shuttle using a school bus.

Mayor Walker reported on the following:

- There will be a Partnership Loudoun meeting on September 23<sup>rd</sup>, 12 noon to 3 PM.
- Jim Morgan will be speaking at the Lovettsville Library on October 11<sup>th</sup> at 11 AM.
- On Saturday October 16<sup>th</sup> at 6 PM there will be a Gold Club event in Purcellville.
- The Balch Library will be holding an event on September 20<sup>th</sup>.
- There will be a Loudoun County Transit Plan Workshop on September 24<sup>th</sup> at Ida Lee Park.
- She and Manager Markel attended a very good meeting with Dominion Virginia Power. They reported
  that they have recently installed some grounding circuits which will reduce the number of power
  outages in Town.
- The Oktoberfest tent will arrive on Wednesday and will be set up the following day in the parking lot next to Andy's Restaurant.
- The auditors will be here on September 29<sup>th</sup>.
- She has received a letter from Town Center explaining that they will be delaying the start of
  construction on the business center due to the standstill in building new homes at Lovettsville Town
  Center and the general inability to get reasonable financing for new loans. This is not a withdrawal.

# Resolution 2008-09-01: APPROVE REDUCTION IN LETTER OF CREDIT NEW TOWN MEADOWS

MOTION: Senate

SECOND: Dockum

WHEREAS, Lovettsville Development Partners, LLC, succeeded to rights to purchase sewer taps for up to 54 residential dwelling units under an agreement dated December 16, 1999, and in accordance with the terms thereof, provided letter of credit No. 419 dated February 26, 2004 and issued by Virginia Commerce Bank in the amount of \$321,300.00; and

**WHEREAS**, Lovettsville Development Partners, LLC, by the terms of the said agreement is entitled to a reduction in the amount of the letter of credit proportionate to the number of taps purchased and placed into service not more frequently than once each 12 months; and

WHEREAS, Lovettsville Development Partners, LLC, has requested approval of a reduction in the amount of the letter of credit to \$71,400, to reflect that 12 taps reserved under the said agreement remain to be purchased.

NOW, THEREFORE, BE IT RESOLVED by the Lovettsville Town Council that the reduction to the amount of \$71,400.00 is hereby approved and that upon presentation of an amended or replacement letter of credit in such amount, approved in form by the Town Attorney as conforming to the requirements of the agreement, the Mayor is hereby authorized to release to Lovettsville Development Partners, LLC, letter of credit No. 419 issued by Virginia Commerce Bank, referenced above. Alternatively, the Mayor may accept suitable correspondence from Virginia Commerce Bank, approved by the Town Attorney, evidencing the reduction in the letter of credit to the amount of \$71,400.00 and stating that the said letter of credit No. 419 otherwise remains in effect in accordance with its terms.
