Staff Reports

A. Report from the Zoning Administrator

The Council had no questions concerning Administrator McGregor's report for October 2010.

B. Report from the Project Manager

Project Manager Fellers presented her report dated November 18, 2010. There were no questions from the Council.

C. Report from the Town Attorney

The Town Attorney had no formal report.

D. Report from the Town Manager

Manager Markel distributed his report at the meeting. The Council had no questions.

Consent Agenda

There were no items on the consent agenda.

Action/Discussion Items

A. Loudoun Wireless

Manager Markel presented this item. At the September 30, 2010 Town Council meeting, the Council granted Loudoun Wireless an additional 60 days beyond the 30 days provided for in the contract to terminate service and remove equipment from the Town's elevated water tank. This extension permitted Loudoun Wireless to remain on the tank until December 14, 2010.

Loudoun Wireless is asking for an additional 30 days to be added to the 60 day extension to allow more time to "move customers, create new systems and reduce the number of current customers that are adversely affected". If granted, the additional 30 days would permit them to keep their equipment on the tank until January 13, 2011. Loudoun Wireless has proposed paying \$1,200 for the additional 30 day extension. They are paying \$2,400 for the previously approved 60 day extension.

Motion: I move that the Lovettsville Town Council allow Loudoun Wireless an additional 30 days beyond the 30 days provided in the existing contract and the 60 day extension approved on September 30, 2010 for the discontinuance of service and full removal of equipment from the Town's elevated storage tank. With the approval of an additional 30 days, the new final date for equipment removal will be January 13, 2011.

Mayor Walker called for discussion. Councilman Dockum asked if this would interfere with the Town negotiating a new contract with another vendor. Manager Markel stated that the availability analysis has not been completed; therefore negotiations are not being delayed at this time. B. Community Development Block Grant (CDBG) Grant Application

Project Manager Fellers presented this item. She explained that the Town has been successful in obtaining funding from CDBG for the design of the first phase of the Broad Way Sidewalk Project from Park Place to the Community Center. That design is complete and the plans are being forwarded to VDOT for review. CDBG is now taking applications for funding for Fiscal Year 2012. She explained that the Town has two options for funding requests for CDBG. As the Town nears the construction stage for Phase I sidewalk, it would be possible to request funding to support the construction of that sidewalk. Because of the many requests combined with limited Federal funds given to the County for distribution under the CDBG program, the typical individual grants awarded are not extremely large. The Town's last funding award was for \$80,000 which was considered one of the larger recipient amounts. Therefore, possible grant funding for construction would cover only a part of the total construction costs. Unfortunately, CDBG funds come from the Federal Government and have several "strings" attached. Use of these funds for construction would require an Environmental Assessment which could take some time and could delay the construction of the project. It will also cost additional engineering funds to complete (estimated to be \$5,000-\$10,000). The CDBG funding also requires all contractors working on the project to meet the wage rates set by the Davis Bacon Act. These wages can be substantial and might increase the total cost of the project. Until the project is bid, it is unclear exactly how much the cost increase for the project would be. Leesburg has stated that they do not believe the Davis Bacon Act requirement has changed their bid prices much but says it does add more paperwork requirements which cause complaints from the contractor.

The use of CDBG funds for the design work of a project is much more straight forward. As Town Council has expressed interest in moving forward with the other segment of Broad Way between Park Place and Church Street (connecting Lake View Village Townhomes with the Post Office, current and future commercial development and the County Library), another option for the Town would be to request CDBG funding to complete the engineering for this Phase II segment. It is unclear how CDBG decision makers will view the Town's request for more funding for design when the first segment designed with their funds has not yet been constructed but the Town can certainly show that the project is moving forward. If funding is not granted this year, perhaps having applied this year will improve the Town's chance for next year.

The resolution is a required element of the funding application. Resolutions for both possible funding requests are included for Town Council's consideration.

Manager Markel noted that the Town would be pushing the time limits for being able to construct improvements if the decision of the Council is to apply for construction funding rather than design funding for Phase II. Councilwoman Coleman asked if doing the Phase II design would be an advantage in

minimizing costs, especially utility placement costs, during construction of both phases. Project Manager Fellers and Councilman Senate agreed that that this could present an advantage.

Motion: I move that Town Council direct staff to apply to CDBG for funding to complete Phase

II Broad Way Sidewalk Design from Park Place to Church Street and approve Resolution 2010-11-01 (Endorsing the application for Community Development Block

Grant funds to assist in Phase II sidewalk improvements along East Broad Way between Park Place and North Church Street for Access to the Lovettsville Library, Post Office, and Current and Future Commercial Areas etc.) to be included in the

Application for CDBG funding for the Broad Way Sidewalk Project.

Mayor Walker called for additional discussion. The Council directed staff to include the costs of engineering from in front of the old post office to the Town Square. While this portion of the sidewalk would not qualify under the middle/low income requirements of CDBG, it would underscore the Town's commitment to completing this project. There being no further discussion, Mayor Walker called for the vote.

C. VDOT Safety-Lu Grant Application

Manager Markel presented this item. He explained that as the Bike Path design moves forward, the Town is applying for additional funds needed to complete Phase II of the Bike Path construction. Based on initial cost estimates, it appears that the already awarded funding will provide for an initial Phase of construction. The intention of this application is to request the additional funds estimated to be necessary to complete an additional Phase of construction. Staff is awaiting information from VDOT and their engineers as to what that amount might be and for what portion of the trail it is expected to complete. It is not necessary to know the amount that the Town will be requesting in the application in order to adopt the resolution. He explained that as part of the application process, it is necessary for the governing body of the requesting community to pass a resolution. This resolution has specific elements required by VDOT where the Town recognizes the Bike Path project, agrees to pay a minimum of 20 percent of the total cost, agrees to enter into an amended agreement for VDOT to administer the project and agrees to reimburse any funds VDOT provides if the Town cancels the project at some point in the future after funds are received by the locality.

D. PHRA Scope for East Broad Way Project

Project Manager Fellers presented this item. Council is being asked to approve a Scope of Services to provide engineering services for the Phase I Broad Way Sidewalk Design during permitting and construction and provide direction on possible water line replacement and underground placement of some of the utilities. The Town was successful in obtaining Community Development Block Grant funds (\$80,000 plus Town match of \$20,000) to design sidewalk along East Broad Way between Park Place and the Lovettsville Community Center (Phase I of the Broad Way Sidewalk Project). The Town hired PHR+A to complete the design and at this time, the design is poised to be sent to VDOT review and PHR+A's original scope of services has been completed. As the original scope only took the project through design, it is necessary to develop a new scope to include bringing the project through the permitting and construction stages.

Since the beginning of the project, it has always been a desire of the Town to eliminate the overhead utilities on Broad Way. Unfortunately, cost estimates developed during the Streetscape Master Plan

development were so high that expectations of being able to bury everything were lost. During the design of Broad Way, staff continued to express an interest in at least burying the service lines crossing the streets to the homes or placing conduits for future underground activities later. The engineer has developed a scope of services to provide the permitting and construction support necessary to bring the Phase I Sidewalk project to completion. Their draft scope of services includes the following main areas:

- 1. Develops the ROW Acquisition and Easement Plats
- 2. Provides design for water line replacement
- 3. Provides Support for plan review and permitting
- 4. Develops bid documents and supports the bidding process.
- 5. Provides Construction Administration support.

PHR+A has identified that the water line is currently underneath Broad Way and is recommending replacement of the line and the laterals as part of this construction project. A memo providing their reasons for this recommendation will be distributed at the meeting. They have indicated that the design work needed to add the water line replacement activities to the plans will take 2-3 weeks of work and therefore will not greatly delay the submission of the plans to VDOT if they receive go ahead from Town Council soon. Many of the items listed above have estimated costs as Not to Exceed. The Town will be billed only the hours needed but will not be billed for additional hours beyond the identified Not to Exceed costs provided in the scope. The total Not to Exceed cost for this support is \$131,100 plus reimbursables estimated at \$5,000. It should be noted that this cost does not include on-site inspection support or the cost for testing. This additional cost will be substantial but is critical to ensuring the success of the project. For budget purposes the testing cost is estimated at a range of \$45,000 - \$55,000. The inspections will be very dependent on the length of the construction phase and will be determined once construction times are determined. In addition to the services provided by PHR+A, there is also the possible need for utility relocation support as well as appraisal and negotiation support for acquisition of ROW and easements. These activities can be provided by specialty consultants and will be discussed separately. During the design process, it was identified that all the Verizon poles on the North side of the street were going to require relocation. As the poles are within the ROW, there is a good possibility that the cost to relocate them may be the responsibility of Verizon; however additional research is needed to verify this. If the Town were to choose to underground the utilities, there may be an opportunity for the Town to ask Verizon to apply the cost of relocating the poles above ground towards the underground cost, thus decreasing the overall cost to underground the utilities. Staff saw this as a possible opportunity for the Town to underground at least some of the utilities without "breaking the bank". A specialty consultant will be necessary to help the Town evaluate this possibility, develop cost estimates and determine the responsibility of the utility companies and is part of the utility relocation support that will be discussed with Town Council separately.

Motion: I move that the Town Council approve the Scope of Services titled *Permitting and Construction Services for Phase I Broad Way Sidewalk* and dated 11/1/10 revised 11/16/10 not to exceed \$131,100 plus an estimated \$5,000 for reimbursables and a contingency of \$15,000 and authorize the Mayor or Town Manager to sign the appropriate paperwork once in a form acceptable to the Town Attorney.

Councilman Senate reported that the new tanker at The Lovettsville Fire and Rescue Department will be dropping water on a daily, weekly and monthly maintenance schedule. He noted that refilling might require coordination with the Town. President Beery stated that the water could be dumped into the

dump tank and then reuse as much of that water as possible to refill the truck. Manager Markel suggested giving them a meter for the hydrant when they refill.

Councilwoman Coleman thanked everyone who attended the Veterans Day ceremonies.

Mayor Walker reported on the following:

- The Board of Zoning Appeals held their annual meeting. She thanked Attorney Whiting for attending.
- Loudoun Places met at the old Waterford School.
- Along with Manager Markel and Supervisor Kurtz, she met with representatives from Congressman Wolf's office concerning the PATH project.
- She attended the Open House held by Dominion Power concerning the rebuild of the existing power line north of Town.
- She reported that the Veterans Day program was well attended and thanked Councilwoman Coleman for providing the flags and poppies that were handed out to the attendees.
- She attended the Excellence in Education banquet.
- She invited everyone to attend the Community Inter-denominational Thanksgiving service at the Lovettsville Fire Station on Tuesday, November 23rd at 7:00 PM.

Manager Markel reminded the Mayor and Council that the December meetings will be on the 9th and the 16th.

Adjournment

The Council went into closed session at 10:17 PM (Attachment VI: Closed Session Motions).

The Council came out of closed session at 11:34 PM and the Mayor read the certification that only lawfully exempted topics were discussed during the closed session. All council members certified this to be true.
