PUBLIC HEARING

The Lovettsville Town Council Public Hearings on LVZA 2011-0004 Sign Ordinance Modifications and LVZA 2011-0006 Contractor Use in Non-Residential Zoning were called to order by Mayor Elaine Walker at 7:32 P.M. at the Lovettsville Town Hall, 6 East Pennsylvania Avenue, Lovettsville, VA 20180.

Welcomes and Introductions

Mayor Walker welcomed the citizens attending the meeting.

The Mayor introduced Vice Mayor Robert Zoldos II and Council Members Tiffaney Carder, Charlotte Coleman, Tim Sparbanie, Shaun Staley and Michael Senate.

The Mayor also introduced the Town Staff, including Town Manager Keith Markel, Attorney Liz Whiting and Town Clerk Judy Kromholz.

Explanation of Procedures and Opening of the Hearing

Mayor Walker read the public notice of these Public Hearings as it appeared in the *Purcellville Gazette* as shown in Attachment I.

Presentation

Manager Markel presented these two items.

The first item was several modifications to the Sign Ordinance. He stated that editorial oversights regarding the Sign Ordinance revisions adopted early in 2011 have been brought to the staff's attention and need to be corrected.

The Sign Committee, the Planning Commission and the Town Council each intended to allow pole signs for businesses. The adopted text for Section 7-5 Sign Standards includes pole sign standards, which indicates that the pole sign is meant to be permitted.

Another staff oversight involves the height allowed for monument signs. The maximum height for such signs in the adopted text of Section 7-5 Sign Standards is 10 feet. Staff failed to differentiate between monument signs for multiple business sites and single business sites. The distinction was, therefore, overlooked when the ordinance amendment was adopted by the Town Council. The standard should include a height limitation of 6 feet for monument signs related to single businesses and residential subdivisions. To allow a 10 foot monument sign for any single business or residential subdivision far exceeds the scale needed and would diminish the small town character of Lovettsville.

Staff has also identified the fact that the adopted Sign Ordinance amendment in 2011 does not prevent multiple OPEN signs for a business or subdivision sales office. It is staff's conclusion that a business should be allowed no more than one OPEN sign per street frontage.

Staff has also rearranged the types of signs alphabetically and added flag signs for commercial and light industrial districts, as was the original intent of the Planning Commission and Town Council. Staff failed to keep this type of sign in the multiple drafts of the text preceding adoption of the Sign Ordinance in 2011.

The second item was an Ordinance Amendment to allow contract uses in the C-2 as a conditionally permitted use and in the i-1 district as a permitted use. Manager Markel explained that currently, contractors who need storage for equipment, materials and vehicles cannot undertake such a business in the Town. The Town needs to be able to attract a comprehensive array of businesses, including building contractors, lawn and snow removal services, swimming pool sales and service, kitchen and bath contractors and equipment sales and service. Staff inadvertently omitted this use from the Light Industrial District (I-1) when it was revised a few years ago.

Manager Markel reported that the Planning Commission had recommended passing both of these items earlier this month.

Public Speakers

Vice Mayor Zoldos explained the procedure for speaking at a public hearing. No members of the audience had signed up to speak. Mayor Walker asked if anyone in the audience wished to speak.

Howard Williamson spoke as a member of the Sign Committee, stating that he strongly encourages the Council to do anything it can to help businesses establish themselves in Town.

Declaration to close the Public Hearing

There being no further speakers, Mayor Walker declared the Public Hearings closed at 7:40 PM.

Call to Order/Welcome/Pledge of Allegiance/Invocation

Mayor Walker led the assembly in the Pledge of Allegiance.

Comments from the Public

Vice Mayor Zoldos read the regulations for speaking at a council meeting. Mayor Walker called on speakers in the order in which they had signed up to speak.

Mr, Bing Lam stated that in 2010 the state legislature had found that the Virginia Retirement System (VRS) has a large unfunded retirement liability and he does not believe that the Town of Lovettsville should be sending money to help out other towns which had joined the VRS earlier. He stated that we are paying for pensions for these people and we do not need to spend any more. Mr. Lam also stated that he does not believe the counting of eligible people was correct. He believes that the clerk position would be covered and was not considered in the submitted calculations. He objects to the current 401k money being allocated to the new fund – he believes there would be two pensions paid to these people until the 401k plan is properly discontinued. At this point, Vice Mayor Zoldos informed Mr. Lam that his three minutes were up.

No other citizens had signed up to speak.

Community Presentations

A. Lovettsville Community Center

Manager Elizabeth Bracey brought information about current programs and presented a report detailing activities at the Community Center in 2011. She noted that there has been tremendous growth in participation – 26% over the prior year. She stated that this increase was partly due to the fact that the Community Center had held more events and partly due to the fact that they are better tracking attendance at events. A new program for teens volunteering at the facility started in 2011 under which 14 volunteers were recruited during the year. She reported that the Lovettsville Community Park hosted three new events last year and is hoping that the Park will soon be open, at least for passive activities. She reported that the County Park Committee is working on the site plan as the next step in that process.

Ms. Bracey reported that the Community Center had been particularly successful at partnering events, especially with the Town, and has become a model for other community centers in the County in this regard. In 2012 the Center plans to continue the movie series and will work with the Lovettsville Game Club to coordinate their annual Carnival with the Independence Day activities to combine them into one longer, integrated event in the community at that time of year.

She went on to report that the Center has had very positive interactions with Deputy Wacker. Vice Mayor Zoldos asked if the incidents of vandalism had abated and Ms. Bracey stated that while the situation has greatly improved, there are still petty crime incidents. She stated that she is taking a very hard line on this.

Manager Markel added the Lovettsville Elementary School PTO playground project as a discussion item.

Staff Reports

A. Report from the Town Attorney

The Town Attorney had no formal report.

B. Report from the Town Manager

Manager Markel reported that he and Project Manager Fellers will be meeting with VDOT tomorrow concerning the bike path and they are hoping that the public hearing will be scheduled for March or April.

He reported that the Planning Commission is reviewing changes to the commission review of by-right zoning applications. He also stated that he has been working on the Keena Subdivision preliminary plat application which should go before the Planning Commission at their second meeting in February. There are a number of exceptions that they will need to consider.

Manager Markel also reported on the single car collision with a fire hydrant that occurred last Friday night. He emphasized that the Loudoun Water staff response was fantastic, including their follow-up efforts on Saturday morning. He reported that the repair parts have been ordered and are expected early next week. He is working with the vehicle's insurance company concerning recouping the costs.

He reported that a second incident involving a hydrant occurred Monday morning but had much less impact on the Town.

Manager Markel reported that the Town website is being upgraded and all of the link and functions may not be working properly during this time. A notice has been posted on the site.

Councilman Sparbanie asked about the Comcast wire that is strewn across a road in Lovettsville Town Center. Manager Markel reported that he and Mayor Walker have met with Comcast. Comcast keeps promising to fix the problem but continues to miss deadlines. The bottom line is that the developer still owns the street in question and the Town has a limited ability to intervene. The developer has not intervened themselves although the Town has informed them of the problem repeatedly. {Treasurer Gladstone arrived during this discussion}. Councilman Staley asked if there is someone at the County level that can intervene with Comcast. Manager Markel stated that they met with the Director of Government affairs at Comcast and she promised action but has not taken any. The developer could cut the line, but Mayor Walker pointed out that that will affect the people who are using the service. Manager Markel asked Attorney Whiting if she knew of any other remedies and Attorney Whiting replied that under FTC rulings all local control has ceased and the state general assembly has said that state franchising is limited to the vendor making a 'good faith effort' and that the Town has no real leverage. There is no market incentive for the franchisee to be a 'good citizen'.

Mayor Walker noted that she and Manager Markel had been up all night dealing with the fire hydrant incident. She stated for the record that Manager Markel performed wonderfully and that they both had fielded phone calls from the Town residents all night. The operators were also here all night and half of Saturday. The Town now has a good chain of command in place for dealing with extraordinary incidents However, the fact that the damage to the hydrant was not reported as an incident is something they are still investigating. Measures are being taken by the Loudoun County Sheriff's Department to make sure notification is done properly. She noted that the citizenry that called during the night were not rude or upset.

Report from the Treasurer

A. Financial Report - November 2011

Treasurer Gladstone presented his report for November 2011. Councilman Sparbanie asked if the meals tax receipts for the new owner of the Loudoun Street Mini Mart would be reported as a separate line item and Mr. Gladstone replied that they would not be reported separately. He noted that the new owner has elected to pay his meals tax on a quarterly basis.

Mayor Walker called for discussion. Vice Mayor Zoldos asked Mr. Williamson if there is anything else that the Town should be doing to support new businesses. Mr. Williamson stated that he could not think of anything at the moment and that he just wants the Town to better explain the process. He said the biggest problem recently has been vandalism – but that has abated recently. There being no further discussion, Mayor Walker called for the vote.

Mayor Walker called for discussion. Councilman Staley asked if this meant that current businesses storing materials outside would be in compliance with the revised ordinance. Manager Markel said that this would only apply to contractor uses in the named zoning districts. There being no further discussion, Mayor Walker called for the vote.

C. Virginia Retirement System Participation

Manager Markel presented this item. Council is being asked to review the Virginia Retirement System actuarial study and provide direction to the Town Manager on moving forward with the implementation of the Virginia Retirement System benefit's program. He explained that the retirement program would be offered to all full-time employees of the Town. Currently, the Town has three employees that would qualify for coverage; two of which are already vested in the VRS from previous employment.

On August 11, 2011, the Town Council authorized funds to have VRS complete the initial actuarial study to determine what the first year costs for participation would be for the Town. The Virginia Retirement System's hired consulting firm of Cavanaugh Macdonald completed the actuarial study and provided their findings to the Town on January 3, 2012. The study shows the breakdown of costs under two scenarios selected by the Town Council. Scenario one reflects the Town's participation with benefits for qualifying members beginning on January 1, 2012. Scenario two includes all of scenario one, along with three years of coverage for past service. The annual cost for scenario one is 12,45% of payroll for the qualifying members, or \$23,487. Scenario two would cost 12.66% of payroll for the qualifying members or \$23,872. The cost of adding three years of prior service is \$385 per year.

He noted that the VRS also offers group life insurance to member localities for an additional fee. The cost to purchase life insurance would be an annual cost of .28 percent of each member's annual compensation. For the Town's current qualifying members, this cost would be an approximate additional cost of \$528.00. To offer this benefit, 75% of eligible members would need to participate in the life insurance program.

Manager Markel went on to explain that once a community elects to participate in the Virginia Retirement System, the membership is irrevocable. Existing qualifying employees would need to be offered the

opportunity to participate in the system, however, they can decline. All new qualifying employees would automatically become members of the program. Once an employee leaves the employment of the Town, the Town's financial responsibilities to VRS cease, however the employee's account would remain and their service benefits would be attached by name to the Town. If the former employee opted to cash out their accrued benefits the account would be closed and if the former employee took employment at a new VRS member locality, the account would transfer to the new employer.

In lieu of membership in VRS, the Town currently provides employees with a contribution to the ICMA-RC 401 plan in an amount equal to five percent of their annual salary. Should the Town Council become of member of the Virginia Retirement System, I would recommend that those funds be redirected towards funding the payments to VRS.

The Town Manager recommends in favor of joining the Virginia Retirement System and providing for the full funding of the benefit, including the 5 percent employee match, for both Plan 1 and Plan 2 participants, along with full coverage for the group life insurance.

Manager Markel noted that this commitment is in the 2012 budget.

Mayor Walker called for discussion. Councilman Sparbanie asked if Mr. Lam's statement regarding the number of hours that qualify an employee for the program was correct. Manager Markel explained that it is his understanding that the Town sets the threshold for eligibility, not VRS. He said that this threshold will be set by Council.

Councilman Staley suggested that the Council hold a work session to review the details of this item before bringing it to a vote. Vice Mayor Zoldos asked Manager Markel if there is any time sensitive issue here and Manager Markel confirmed that this is not time sensitive. Vice Mayor Zoldos supported the idea of holding a work session, noting that this is a future obligation that could be staggering to the Town and it must be evaluated in that light.

D. Town Green Bandstand Resolution of Support

Manager Markel presented this item. Council is being asked to set a budget for the Bandstand/Gazebo and provide direction on next steps. He explained that the Town has always planned to install a Bandstand/Gazebo in the Town Green. A concept plan developed by Town Center Development as well as the Town Green Concept Plan developed by the Town shows a Bandstand structure. The Town has budgeted \$45,000 for the development of the structure in FY 2012. The Parks Committee has begun work on developing this bandstand structure and has identified that the bandstand/gazebo needs to be attractive and functional and that careful selection of the structure is critical. After conducting some initial pricing on gazebo kits as well as the costs for architectural design support, the Parks Committee has identified a desire to utilize a professional architect to design the structure and that a budget of Not to Exceed \$150,000 will provide the resources to construct a bandstand structure that will be a signature landmark in the community as well as attractive and functional for events held at the Town Green. Staff, in consultation with representatives from the Parks Committee has a Resolution for Town Council consideration. If Town Council chooses to pass the resolution, the Parks Committee recommends approving the Phase 1 Scope of Services with Architect Clint Good.

Motion: I move that Town Council approve Resolution 2012-01-003 to Support the Construction of a Town Bandstand in the Town Green (Attachment V). I further move that Town Council authorize the Mayor or Town Manager to sign the necessary paperwork to initiate Phase 1: Town Green Bandstand Programming/Schematic/Budgeting Services with Architect, Clint Good, for a cost not to exceed \$9,000.

Mayor Walker called for discussion. Councilman Senate stated that the Committee sees this as a very important part of the Town, and feels it must be sized to the site and designed to fit in with its surroundings. He stated that it must not dwarf any of the adjacent homes. Councilman Sparbanie asked if the committee has been in touch with the surrounding homeowners. Councilman Senate stated that the committee does not have anything new to show the residents — all of the drawings showing this structure pre-date any of the homes. Adjacent homeowners will be personally invited to the public input portion of this process.

Councilman Staley stated that it would probably be in the Town's best interest to authorize payment for the rendering in order to have it available at the public input sessions. Councilman Senate explained that the basic black and white drawing will be provided in any case, the additional expense would be to provide color and CAD produced designs for the public to review. Vice Mayor Zoldos stated that he does not like the fact that the Town would be paying for a draftsman and not receiving an architectural rendering. Manager Markel explained that the product the Council is seeking would normally be produced during Phase II of the project, when renderings are produced so that the project can be put out for bid.

Vice Mayor Zoldos stated that he would like to see 3D renderings that the homeowners can rotate in order to see exactly what the structure would look like from their perspective. Mayor Walker stated that she would like to see a more detailed description of the product before allocating this money. She is very uncomfortable with the 'undetermined amount' part of the proposal.

Councilman Staley stated that the preliminary renderings must include enough reference points to clearly show the scale of the proposed structure. Councilman Senate stated that he would like to see more specific information explaining exactly what the Town would be paying for in this phase of the project. Vice Mayor Zoldos stated that he would like the contract modified to ensure that we get a computer generated model from this step. Mayor Walker noted that the Town still has the option of selecting a commercial kit, as researched by Project Manager Fellers and Manager Markel. Vice Mayor Zoldos stated that he does not feel that the architect is committed to providing the Town with what is needed to present the project to the public.

The Council declared a recess at 9:30 PM and came out of recess at 9:42 PM to allow staff to pull together some images that have been filed away.

Manager Markel provided Council with some pictures from the architect's website showing what might be provided under the contract. He recommended that staff go back to the architect and request more details on the product to be delivered from this phase of the project. Vice Mayor Zoldos asked Manager Markel to specifically ask for samples and to get a firm price on color renderings.

before MayFest will be part of the MayFest budget. The Council discussed possible parking solutions, the parking of fire trucks throughout the event, the hayride and the need for handicapped parking. Vice Mayor Zoldos presented a tentative budget totaling \$4,999. The committee is asking the Town for \$5,000 to fund the first year of the event and stated that income from this year will serve a seed money for next year's MayFest and thereby help insure that this is an on-going event. Councilwoman Carder explained that the committee is still researching the requirements for ABC licensing.

Motion: I move that the Town Council officially establish MayFest as one of the Town's sponsored events and appoint Councilwoman Carder as Chairwoman of the event

committee.

F: Lovettsville Elementary School Playground Project

Manager Markel presented this item. He reported that the PTO is asking for additional funding from the Town. Mayor Walker said that she was surprised that they were trying to raise all the funds out of this year's funding cycle. Councilman Sparbanie suggested deferring this request and asking them to report on what their total fundraising has been so far from other groups. Vice Mayor Zoldos agreed and stated that the Town needs to explain that it cannot allocate from next year's budget until next year and that this may not meet their scheduling needs. The Council all expressed their support for this project but do not want the Town to be the sole sponsor. Vice Mayor Zoldos noted that although he supports helping the PTO with the Playground project, this is another example of the Town funding a project on County property without the County providing support back to the Town.

Information Items

No information items were presented.

Comments from the Mayor and Town Council

Councilwoman Carder thanked everyone for all the support she is getting for MayFest.

Councilman Senate reported that there is still a problem with speeding vehicles on Loudoun Street.

Councilwoman Coleman thanked everyone who had brought in food for the Lovettsville Food Bank.

Councilman Staley thanked Manager Markel for all of his work in resolving the problems brought on by the automobile/hydrant accident.

Vice Mayor Zoldos reminded everyone that there will be PTO bingo and a chili cook-off tomorrow night at the Lovettsville Elementary School

Mayor Walker reported on the following:

- The Coalition of Loudoun Towns meeting she attended was very informative.
- The office hours she and Councilwoman Coleman held earlier this week was very well attended.
- She plans to continue meeting with Comcast to resolve open issues.
- She attended the Visit Loudoun event yesterday and the Chamber of Commerce luncheon earlier today.

i. Maximum Height: Ten (10) feet for sites with multiple Businesses; and six (6) feet for sites with single businesses and residential subdivisions.
