Action/Discussion Items

A. Draft of Community Vision Workshop Agenda & Set Up

Zoning Administrator Hynes presented this item. She discussed the three-step process for getting public input for the Old Town District which will include a survey of property owners located within the target revitalization area, a community workshop/open house, and a community survey. The first step is to survey the property owners. Staff and the Commissioners discussed minor changes to the letter and survey, which will be mailed to property owners and tenants in the Old Town District.

Staff and the Commissioners discussed potential dates for the community workshop in October 2012. The workshop will be structured as an open house and will include six interactive stations for residents to learn more about the future of the Old Town District and to provide their input. Staff and the Commissioners discussed the format and content for the stations.

B. Draft of Community Vision Survey

Zoning Administrator Hynes reviewed the questions for the Community Vision Survey. The survey will be distributed at the community workshop and posted on the Town's website. Staff and the Commissioners discussed minor changes to the survey.

Councilman McIntyre reported on the following on behalf of Mayor Zoldos:

- The Town Manager's evaluation will be completed in September.
- The Economic Development Advisory Committee will hold a vision meeting on September 17 at the Community Center. The Commissioners are encouraged to attend.
- Lovettsville native Rob Jones earned a bronze medal at the Paralympics in London.
- The flag pole will be replaced soon.
- The Montessori School is now open, the Mad Horse Brew Pub will be open in time for Oktoberfest, and the Kissmett Spa will have a ribbon cutting in the next few months.
- Mayor Zoldos will serve as the Master of Ceremony for the Lovettsville-Waterford Ruritan Club Barn Dance.
- Painting on the elevated water tank will begin in a few weeks.

Councilman McIntyre said Oktoberfest is three weeks away and he invited the Commissioners to volunteer for the event. Commissioner Mueller asked if the Town will have a booth at Oktoberfest. Commissioner McIntyre said the Town may have an open house at Town Hall instead.
