Report from the Treasurer

Staff Reports

A. Report from the Project Manager

There were no questions from the Council regarding the Project Manager report dated November 9, 2012. Manager Markel noted that the elevated water tank is back online. Mayor Zoldos said that he. Council Member Burden, and Planning Commissioners Gentile and Quinta will be attending the tour of the Town's water and sewer facilities next month.

B. Report from the Zonina Administrator

Zoning Administrator Hynes gave her report for October 2012. There were no questions from the Council.

C. Report from the Town Attorney

There was no formal report from the Town Attorney.

D. Report from the Town Manager

Manager Markel gave his report. He noted that Loudoun Water did a great job maintaining the Town's water/sewer treatment facility during the recent storm. He announced that Melissa Hynes will be working for the Town full time.

Action/Discussion Items

A. Sprint Antenna Conditional Use Permit

Zoning Administrator Hynes presented this item. Council is being asked to consider a request by Sprint, for approval of a new Conditional Use Permit to Section 3-3 (c)(xi) of the Lovettsville Zoning Ordinance, to allow for the installation of wireless communications equipment as a conditionally permitted use. The parcel is located at 14A Quarter Branch Road. The Town Council Public Hearing for LVCU 2012-0004 is scheduled for December 8, 2012. In preparation for the public hearing, Staff addressed questions from Council Members regarding microwave interference, stress limitations, proper installation of the equipment, painting, and the availability of new slots on the tank.

B. Digital Council Packet Tools

Manager Markel presented this item. Council is being asked to consider transitioning to using electronic tablets to receive and review Town Council packets and communications. There was support among the Council Members for transitioning to a digital format; however, Council decided to form an ad-hoc committee to look into some the issues that had come up during the discussion including the use of personal equipment and costs. Councilman Burden asked about establishing the rules of the committee. Mayor Zoldos said this would be done at the first meeting.

C. Tree City USA Application

Zoning Administrator Hynes presented this item. Council is being asked to consider adopting a Lovettsville Tree Conservation Ordinance in order to meet one of the four requirements necessary in applying to become a member of Tree City USA. Following discussion, Council directed Staff to add this item to the agenda for December 8, 2012 to give them more time to review the materials.

D. Generators

The Mayor and the Council discussed authorizing the Town Manager to negotiate purchasing surplus equipment, including a pump, air compressor, and two generators.

Motion: To authorize the Town Manager to negotiate with the owner of the equipment to

purchase those devices, if still available, for \$6K or less; which is the cost of the

largest generator.

Councilman Burden said it is not clear if the largest generator will meet the Town's needs.

E. Rate Study

Manager Markel said the deadline for submitting proposals for the water/sewer rate study is November 16, 2012. The Town has received two proposals so far and the cost estimates are in the \$18,000 to \$25,000 range. The next step is to form a Selection Committee and schedule a meeting to review the proposals. Mayor Zoldos and Council Members Gray and Burden volunteered to serve on the Selection Committee and the meeting was scheduled for December 8, 2012.

Information Items

No information items were presented.

Comments from the Mayor and Town Council

Councilman Burden said that he and Council Member Allar had been sworn into office earlier that day.

Councilman McIntyre congratulated Council Members Burden and Allar on their recent election. He heard many good things about the Veterans Day Ceremony. He said there was a great turnout for the Catoctin Holiday Art Tour.

Mayor Zoldos reported on the following:

- The Town recently referred two potential tenants for the second-floor of the Town Center to the
 developer; however, the lease costs have now increased substantially so this may not be a solution to
 finding tenants for the second-floor space.
- He attended four of the stops on the Catoctin Holiday Art Tour. He would like to explore how to make this more of a Town sponsored event next year.
- The Kissmett Spa Ribbon Cutting and Open House was held on November 5.
- He thanked Melissa Hynes for coming on board full-time. He explained that her time will be allocated between zoning administration, tourism, and business development.
- The County will be conducting a community input meeting on November 29 at 7:30 PM regarding options for renovations to the Lovettsville Community Center.
- He attended the retired teacher luncheon at the Lovettsville Elementary School on November 11.

- Gary Lowry will be taking over as the new owner of the Mini Mart. December 1 is the tentative opening date.
- Residents can now sign up for Lovettsville specific events through Alert Loudoun.
- The Inova Hospital facility in Town is still not open.
- The Veterans Day Ceremony was spectacular.
- He was contacted by representatives from the Game Club about conducting an event in April so that residents can learn about all of the volunteer events at one time.
- Woodgrove High School will be conducting a craft fair/market place on November 18.
- Lovettsville Stop Hunger Now needs volunteers for their meal packaging event on December 1.
- Christkindlmarkt will be held on November 24 and 25.
