

Town Council Minutes of the June 13, 2013 Regular Meeting

Pledge of Allegiance

Mayor Zoldos led those assembled in the Pledge of Allegiance.

Presentations

There were none.

Closed Session

Mayor Zoldos announced that the Council would be going into closed session to discuss the Town's waste water treatment plant.

Comments from the Public

Jennifer Jones, 24 Black Forest Lane, came forward to speak. She asked the Town Council to consider establishing design guidelines that can be used by the Planning Commission and Staff. She said the Town is growing and they need these guidelines for prospective new businesses.

Community Presentations

A. Loudoun County Sheriff's Office

Deputy Sheriff Lopreto gave an update on recent incidents reported in and around Town, including a larceny on Lovett Drive involving an unlocked vehicle and burglaries at West End Motors and the Bridge End Center. He said he is seeing fewer garage doors left open and it will help to get the 7-Eleven open 24 hours. He is continuing to work on speeding violations on West Broad Way. He suggested that the Town ask VDOT for a second 25 mile per hour sign near Spring Farm Drive.

Councilman McIntyre asked what is involved in getting a radar speed sign. Deputy Lopreto said the Town would have to purchase and maintain the sign. Mayor Zoldos said the Council had looked into this before and had been told by a former Deputy Sheriff that the signs were not a very effective deterrent for speeding. The Mayor also said the signs are expensive.

There were no other community presentations.

Town Commission and Committee Reports

A. Lovettsville Planning Commission

Manager Markel said the Planning Commission is meeting once a month for the summer. The Commission will be reviewing the Town's Comprehensive Plan at the meeting next week.

B. Parks Committee

Vice Mayor Senate said they hope to dedicate the Walker Pavilion soon. Manager Markel said the dedication is scheduled for Saturday, July 29.

C. "We're In" Committee

Mayor Zoldos gave updates on the recent "We're In" committee meeting, the selection and final design of the new Town seal, and the new Lovettsville Business and Community Directory. Manager Markel said "We're In" will also have a presence at the July 3rd parade.

D. MayFest Committee

Councilwoman Carder gave an update on MayFest. There were 62 vendors and 13 sponsors. The total revenue for 2013 was \$8,879.72 and expenses were \$7,725.23. They were able to cover all of their costs and will not need the \$2,000 provided by the Town. The MayFest Committee had a good de-briefing and most of the volunteers will be coming back next year. Councilwoman Allar has agreed to serve as Vice Chair next year. She said they will need more volunteers for set up. Mayor Zoldos asked if there will be an after-action report for the event. Councilwoman Carder said the vendor fees and the logo design will be the same. Some of the changes include stronger outreach to Brunswick, better layout, shorter hours, fewer bands (three instead of four), modifications to the race times, and T-shirts for event staff.

Mayor Zoldos thanked Councilwoman Carder and the MayFest Committee for doing such a great job. He asked if there were any questions from the Council.

Vice Mayor Senate suggested they start thinking now about how to handle parking and traffic, and consider closing the streets much earlier.

E. Oktoberfest Committee

Councilman McIntyre gave updates on logistics, safety, and trash/recycling collection.

Additions/Deletions/Modifications to the Agenda

Mayor Zoldos asked if there were any changes to the agenda. Hearing none, the Mayor said he would like to remove Item C (Discussion on Park Movie Equipment) because the Town Manager may have come up with a solution.

Report from the Treasurer

Treasurer Lance Gladstone presented the Financial Report for April 2013.

Mayor Zoldos asked if the Town is current on payments to Loudoun Water. Treasurer Gladstone confirmed the payments are up-to-date. Manager Markel said he has had several discussions with Loudoun Water about the outstanding invoices. He has received an explanation for the costs, which include materials, additional maintenance, and routine service. They are looking at an average of \$30,000 per month for Loudoun Water's services.

Councilwoman Allar asked if Bonnie's is current on the meals tax. Treasurer Gladstone said Bonnie's has been invoiced for the first quarter of 2013, but the bill has not been paid. He said he gave her until

mid-July to bring the payment current. Councilwoman Allar asked if the Thai food truck has had to pay meals tax yet. Treasurer Gladstone said their first payment was made in May 2013.

Staff Reports

A. Report from the Project Manager

There was no written report from the Project Manager.

B. Report from the Zoning Administrator

There was no written report from the Zoning Administrator. Manager Markel said he will be serving as the Zoning Administrator while Melissa Hynes is on maternity leave.

C. Report from the Town Attorney

Attorney Whiting said she will be out of town the week of July 5-14, 2013.

D. Report from the Town Manager

Manager Markel gave updates on the code codification process and the Virginia Municipal League (VML) Town Section Meeting he attended on June 12, 2013. He distributed VML's summary of legislation affecting towns enacted in the 2013 session of the General Assembly. He noted a new provision for Council Members to attend meetings remotely and vote up to two times a year, if agreed to by fellow Council Members and provided there is a quorum of the Council in the location where the official meeting is taking place. There is no limit to the number of meetings that Council Members can attend remotely in the case of a medical emergency.

Manager Markel distributed and discussed his monthly report. He noted that things are moving forward with the site work and tree relocation for the Quarter Branch Park Facility. There were no questions from the Council.

Action/Discussion Items

A. FY 2014 Budget, CIP, Schedule of Fees Adoption

Manager Markel presented this item. He presented two ordinances related to the adoption of the FY 2014 Budget, Capital Improvement Plan, and Schedule of Fees and noted minor changes brought to his attention by Councilman Burden.

Mayor Zoldos called for discussion. Councilman McIntyre brought up the issue of the Council Members' compensation. He said the discussion has been put off a number of times because they did not have a full Council, which is the case tonight. He said he is opposed to any increase. There are five Council Members who have not completed a full term in office and four Council Members who have not completed one year in office; therefore, he did not feel it was appropriate to double the compensation.

Councilwoman Carder said the increase in compensation reflects all of the hard work the Council Members do on behalf of the Town, including the newer members. She asked if Councilman Gray had submitted a comment on this issue. Manager Markel said he did receive an email from Councilman Gray, which he forwarded to the Mayor. Mayor Zoldos read the email from Councilmember Gray asking the Mayor and Council to hold off on voting on this tonight because he is working and cannot attend the meeting. He further stated he is against this being passed.

The Town Attorney said the Council could approve the budget, except for the allocation of this specific line item, which could be acted on at a later date.

Mayor Zoldos called for further discussion. Councilwoman Allar said that as the newest member on the Council, it would be hard to say yes to increasing the compensation. When she ran for Town Council she did not know the Council Members were compensated. She said that with additional compensation she would be able to attend more meetings during the day because she could hire someone to take care of her children.

Vice Mayor Senate said when this issue was first brought up it was a way to make up for the output as a whole, not how long someone has served on the Council. All of the Council Members are actively involved in various Town events. He could not recall the last time the Council Members' compensation was increased. He said people should be paid on merit and that this Council is a meritorious group.

Councilman Burden said the compensation should be based on putting the time in, not how long someone has served on the Council. Personally, he would not raise the compensation at all. He considers it a volunteer service, but it is not that way for everybody. It may be easier to get people to serve on the Council if the compensation was higher.

Mayor Zoldos said that while increasing the compensation is problematic for many reasons, including the state of the economy, he has asked this Council to do more than they have ever done. If this passes, he asked the Council Members to put in the time by making the Town a focus point. The increase is based on the expectation that they will do more work. He said this is also a fairness issue and that serving on the Council should not be a financial disincentive for anyone. In the past, there have been Council Members who did not make the Town their focus. He stressed that the Council Members have to play an active role in the community.

Following further discussion with the Town Attorney about options for approving the budget without appropriating funds for the Town Council compensation line item, Vice Mayor Senate made the following friendly amendment:

Motion: I move to adopt Ordinance 2013-06-002 to approve the Budget and CIP, Adopt Tax Rates and Make Appropriations for Fiscal Year Ending June 30, 2014, with the exception of expenditure 104210.1002 Town Council Salaries (Attachment 2).

Councilman Burden accepted the friendly amendment.

Ordinance 2013-06-001: AMEND TOWN OF LOVETTSVILLE SCHEDULE OF FEES TO REVISE WATER AND SEWER USER CHARGES

MOTION: Senate SECOND: Burden

WHEREAS, the Town Council periodically reviews its schedule of charges and fees to establish practicable and equitable fees and charges for users of the public water supply and sewage disposal systems; and

WHEREAS, the Town contracted with Municipal and Financial Services Group to conduct a thorough evaluation of the Town's utility finances and expenses to develop a multi-year rate plan to ensure the Town's utility system is fiscally strong and able to provide its users with high quality water and sanitary sewer service; and

WHEREAS, the Town Council has determined it is fair and reasonable to increase the user rates 3 percent for water service and 6 percent for sewer service for fiscal year 2014.

WHEREAS, notice of the proposed changes has been given in accordance with the requirements of Virginia Code Section 15.2-107.

NOW, THEREFORE, BE IT ORDAINED that the Town's Schedule of Fees, be amended as set forth in the schedule attached hereto. This ordinance shall be effective after the 30th day of June, 2013.

WHEREAS, the budget, capital improvement plan (CIP), and tax rates for the fiscal year ending June 30, 2014, have been prepared and reviewed by the Town Council; and

WHEREAS, a brief synopsis of the proposed budget and CIP and notice of a public hearing to be held in the Town office on May 23, 2013 at 7:30p.m. were published in the public notices section of the Purcellville Gazette on May 10, 2013; and

WHEREAS, a public hearing was in fact held at the time and place advertised at which citizens had the right to attend and state their views on the budget and tax rates.

IT IS ACCORDINGLY ORDAINED by the Town Council of the Town of Lovettsville as follows:

- 1. The proposed budget and CIP are approved as presented.
- 2. Appropriations are hereby made for the fiscal year ending June 30, 2014, in the amounts shown to the categories and accounts therein for the general and utility funds and Frye Court Service District fund, with the exception of expenditure 104210.1002 Town Council Salaries.
- 3. All outstanding operating encumbrances at June 30, 2013 are hereby reappropriated for the 2014 fiscal year to the same department and account for which they are encumbered in the previous year.
- 4. At the close of the fiscal year, all unencumbered appropriations lapse for budget items other than any capital projects and grants.
- 5. The tax rates and license fees for FY 2014 are hereby fixed at the levels shown in the attached schedule.
- 6. Water and Sewer rates shall be set as provided in the Town's Schedule of Fees, as amended by ordinance approved immediately prior hereto.
- 7. The tax rate for FY 2014 for the Frye Court Service District shall be fixed at \$0.275 per one hundred dollars (\$100.00) of assessed value for taxable real estate (exclusive of improvements).
- 8. Land use charges imposed as provided in the schedule of fees hereto attached, adopted by ordinance.

- 5. Discussion concerning a prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the business' or industry's interest in locating or expanding its facilities in the community,
- 6. Discussion or consideration of the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of the governmental unit would be adversely affected,
- 7. Consultation with legal counsel and briefings by staff members or consultants pertaining to actual or probable litigation, where such consultation or briefing in open meeting would adversely affect the negotiating or litigating posture of the public body; or consultation with legal counsel employed or retained by a public body regarding specific legal matters requiring the provision of legal advice by such counsel [For the purposes of this subdivision, "probable litigation" means litigation that has been specifically threatened or on which the public body or its legal counsel has a reasonable basis to believe will be commenced by or against a known party. Nothing in this subdivision shall be construed to permit the closure of a meeting merely because an attorney representing the public body is in attendance or is consulted on a matter],
