Pledge of Allegiance

Mayor Zoldos led those assembled in the Pledge of Allegiance.

Comments from the Public

Mayor Zoldos called for comments from the public. Vice Mayor Mike Senate read the rules for public comments. Elaine Walker, 40 S. Berlin Pike came forward to speak (Attachment 1). She read a letter to the Mayor and Town Council thanking them for the dedication of the Walker Pavilion (Attachment 2).

Community Presentations

A. Loudoun County Sheriff's Office

Deputy Sheriff LoPreto gave a PowerPoint presentation on Sheriff's Office coverage in the Lovettsville area and the number of incidents reported in the first six months of the year in Western Loudoun. He said that the incidents reported in the Lovettsville area are relatively low compared to other parts of the County and most crimes are down compared to 2012. Residents can now report a crime online through the Sheriff's Office website. Deputy LoPreto said the best thing people can do to prevent criminal activity is to lock their cars and garages.

Mayor Zoldos thanked Deputy LoPreto for his participation in National Night Out. He expressed concern that Deputy Cooper had been re-assigned to another area and said he would speak with the Sheriff's Office about getting another Deputy assigned to the area.

Report from the Treasurer

Treasurer Lance Gladstone presented the May 2013 Financial Report. He noted that Bonnie's restaurant is delinquent in paying their meals taxes again and he has imposed a bank lean for the first three months of the 2013. All of the outstanding Loudoun Water invoices have been paid.

Mayor Zoldos asked about the high expenditures with Loudoun Water. Manager Markel said the invoices reflect billing practices, purchase of actual goods, and engineering/consultant support. He will be working with the new management at Loudoun Water on finalizing the new contract and monitoring expenditures. Hearing no further discussion, Mayor Zoldos called for a motion.

Motion: I move to accept the May 2013 Financial Report.

Mayor Zoldos called for discussion. Vice Mayor Senate said he was concerned that this is the second time Bonnie's has been delinquent on the meals tax. Treasurer Gladstone said he will monitor this more closely. He noted that meals taxes are paid quarterly and that he has to wait 30 days after the due date before he can impose a lien. Councilman McIntyre asked if the lien was based on an estimate. Treasurer Gladstone said the lien amount was based on estimated taxes, an escalator, plus a 10% penalty.

Staff Reports

A. Report from the Project Manager

Manager Markel gave updates on smoke testing of the sanitary sewer system and construction of the Quarter Branch Park Facility.

B. Report from the Zoning Administrator

Manager Markel said the Town received a preliminary plat for a new subdivision. The project will be presented to the Planning Commission next month after referral organization comments are received.

C. Report from the Town Attorney

There was no report from the Town Attorney.

D. Report from the Town Manager

Manager Markel gave updates on the code review process, the water leak on East Broad Way, and National Night Out.

Action/Discussion Items

A. LVCU 2013-0002 AT&T Telecommunications Equipment on the Elevated Tank (Public Hearing)

Presentation

Manager Markel presented this item. The Council is being asked to consider a request from AT&T to modify the existing communications equipment on the Town's elevated water tank.

Manager Markel reviewed the Applicant's request to install new equipment on the tank and the structural analysis completed by the Town's engineering firm. The Planning Commission held a public hearing on this item at their meeting on July 17, 2013. No public comments were received for or against the request. The Planning Commission voted unanimously to recommend approval of the Conditional Use Permit with the following conditions as presented by staff:

- This approval is for equipment as shown on the Site Plan & Project Summary dated April 9, 2013; six (6) Remote Radio Heads and related cables; as well as two cabinets to be mounted inside the fenced, leased space on the ground near the elevated tank. (The three proposed antennas are a permitted use under the previous conditional use permit)
- 2) Antennas, cables and associated equipment located on or attached to the tank must be painted to match the color of the tank; except for the Remote Radio Heads (RRH), which will be enclosed in a colored covering to match the tank.
- 3) Regular maintenance activities for this facility shall be limited to the hours of 8:00 AM and 6:00 PM, Monday through Friday. For maintenance or replacement activity that requires entering the fenced in water tank area, the applicant shall notify the Town Office at least twenty four (24) hours in advance
- 4) No outdoor storage, other than what is shown on the site plan, shall be permitted in association with this use.

- The proposed use shall be passive and will not generate noise, dust, light, glare, vibrations, traffic or odors.
- 6) The proposed use shall not interfere with area telephone, radio, television reception or the signal of other co-located communications equipment.
- 7) This Conditional Use Permit shall be co-ext with any lease entered between the applicant and the Town as owner of the real property on which the approved facilities are to be located. The Permit shall terminate upon expiration or termination of such lease.

Manager Markel said that the purpose of tonight's meeting is to accept comments from the public. The Council will take action on the Applicant's Conditional Use Permit once a new contract is agreed to by both parties.

Renee Frustaci, from AT&T, gave a brief PowerPoint presentation on the provisions of the current lease rights, the equipment that is actually installed, and the additional equipment that is being proposed.

There were no questions from the Council.

Public Hearing

Mayor Zoldos opened the public hearing for LVCU 2013-0002 at 8:23 p.m. Vice Mayor Senate read the Notice of Public Hearing (Attachment 3).

Mayor Zoldos called for comments from the public. Hearing none, he closed the public hearing at 8:25 p.m.

B. LVCU 2013-0003 7-Eleven Hours of Operation (Public Hearing)

Presentation

Manager Markel presented this item. The Council is being asked to consider a request from the 7-Eleven Convenience Store to allow the business to operate 24 hours a day, 7 days a week.

The owner of the 7-Eleven store, Pardip Sindu, recently requested that the Town Council consider modifying the existing Town Zoning Ordinance that required all Town businesses close to the public between the hours of 12:00 a.m. and 6:00 a.m. As a result, the Town recently modified the Zoning Ordinance to allow businesses to expand their hours of operation through a Conditional Use Permit.

Manager Markel reviewed the location of the store in relation to adjacent property owners. Staff feels that the store's location makes it appropriate to allow for expanded hours of operation, as the likelihood that any residential uses would be adversely impacted is very minimal. He also reviewed other factors used to evaluate the Applicant's request including public safety and convenience for residents.

The Planning Commission and Staff support the request to expand the current hours of operation for the 7-Eleven store to a full 24 hours a day with the understanding that the business operator will fully comply with all Town ordinance requirements along with the following recommended condition.

 The Conditional Use Permit will be reviewed administratively each year. If violations are found, the Zoning Administrator will bring the permit back to the Planning Commission for their full review.

Public Hearing

Mayor Zoldos opened the public hearing at 8:30 p.m. Vice Mayor Senate read the Notice of Public Hearing (Attachment 3).

Mayor Zoldos called for comments from the public. Hearing none, he closed the public hearing at 8:32 p.m. The Mayor then called for a motion.

C. HEAL Town Resolution

Manager Markel presented this item. The Council is being asked to consider adopting a resolution to participate as a Healthy Eating Active Living (HEAL) community with the Institute for Public Health Innovation. The goal is to have local governments play a more visible role in promoting healthy lifestyles by supporting greater access to healthy food and recreational opportunities. This can be as simple as promoting healthy restaurant options, farmers markets, along with bike trails and public parks; all things that are low cost or are projects that many communities already support.

Manager Markel reviewed the various aspects of the draft resolution noted the Town is already doing many of these things. The program requires minimal staff time, depending on the level of involvement a community makes to the HEAL program. It is non-binding and does not require ongoing participation.

Staff recommends that the Council pass the resolution to becoming a participating community for the coming year and reevaluate the Town's participation next year to evaluate if the program is of benefit to the community.

Mayor Zoldos said this would help with funding for sidewalks on Loudoun Street through Safe Routes to School and it allows the Town access to the HEAL farm market consultant.

Motion: I move that the Lovettsville Town Council adopt resolution 2013-08-001, as attached,

to become a HEAL Town in partnership with VML and the Institute for Public Health

Councilman McIntyre said he was excited to see some of the community groups, like the Lovettsville Garden Club and the Lion's Club, getting involved in these activities.

D. Town Center Section 2 VDOT Street Acceptance Resolution

Manager Markel presented this item. The Council is being asked to consider adopting a resolution in support of VDOT acceptance of the streets within Lovettsville Town Center Section 2.

Town Center Lovettsville LC (Elm Street Development), the developer of Lovettsville Town Center, has completed all necessary street improvements within Section 2 of the project to allow for the Virginia Department of Transportation (VDOT) to assume maintenance responsibilities of the road and related infrastructure. Now that road construction within Section 2 has been completed, the developer has asked that the Town formally request that VDOT assume maintenance responsibilities for the public streets. Streets in this section include portions of Black Forest Drive, Hammond Drive, Eisentown Drive, and Kimberly Kristin Way.

E. Town Center Section 4 Performance Bond Acceptance

Manager Markel presented this item. The Council is being asked to consider accepting a performance bond for the public improvements related to the development of Section 4 of the Lovettsville Town Center.

In order to begin installation of public infrastructure the developer must post a performance bond for the public improvements that will be installed as part of this section. The Town uses the Loudoun County bond worksheets to set bonding amounts for all public infrastructure. All parties agree with the bonding amount of 3,853,000 for the public improvements in Section 4, the final phase of the development.

F. Town Council Compensation for FY 14

Manager Markel presented this item. The Council is being asked to review and decide the annual compensation for Town Council members for FY 2014. Manager Markel distributed an updated summary of town officials' annual compensation from surrounding localities for FY 2014.

Mayor Zoldos said they had been waiting until the full Council was present to take action on this item. He called for a motion.

Motion: I move that the Lovettsville Town Council modify the annual compensation to Town

Council members to the new level of \$2,000 per year, to be paid in quarterly

installments.

Mayor Zoldos called for discussion.

Vice Mayor Senate said there were really strong feelings in both directions on this issue. The original amount suggested was \$2,400. Unless someone wants to make a different motion or modify the motion, they should move forward.

Councilman McIntyre said that four of the six Council Members had served on the Council for one year and he did not feel it was appropriate to ask for more money.

Councilman Burden said it has more to do with what they do, not how long they have served. Every significant event in Town is led by the Council Members.

Councilman Gray said that the whole idea is to serve the Town. He is opposed to the increase for many reasons and would like to see the compensation remain the same.

Vice Mayor Senate said he has served on the Council for many years and initially there was no compensation. He considers it an honor to serve the Town.

Councilwoman Carder said she agrees with Councilman Burden and Vice Mayor Senate. The Council Members work really hard and it is an honor to serve the Town. She felt that \$2,000 was appropriate.

Councilwoman Allar said she did not sign on for the money. Considering the time requirements, she felt it does justify additional compensation, especially for future Council Member. They need to make it worth wanting to be on the Council.

Mayor Zoldos said he has been on the Council for many years and the demands of serving the Town have increased over that time. None of the Council Members decided to serve based on the compensation. The compensation should be set at a level that it does not cost the Council Members to serve the Town. He said if they raise the compensation, the Council Members need to understand that it is because they are requiring more of everyone.

Mayor Zoldos called for further discussion. Hearing none, he called for the vote.

Mayor Zoldos said the former Chair of the Planning Commission, Michael Wild, used to conduct something similar each summer. The Mayor and Council discussed calling the event "Wild on the Green," in honor of Mr. Wild, who passed away several years ago.

annual "Wild on the Green" picnic and kickball game.

RESOLUTION 2013-08-001: SETTING FORTH LOVETTSVILLE'S COMMITMENT TO PROMOTING A HEALTHY COMMUNITY

MOTION: Senate SECOND: Carder

WHEREAS, the Town of Lovettsville has the ability to affect the health of its residents through planning, public facilities, and promoting a healthy community; and

WHEREAS, planning and constructing a built environment that encourages walking, biking, and other forms of physical activity can promote health; and

WHEREAS, high rates of costly chronic disease among both children and adults are correlated to environments with few or no options for healthy eating and active living; and

WHEREAS, the current generation of children are expected to have shorter lives than their parents due to the consequences of obesity; and

WHEREAS, the annual cost to Virginia—in medical bills, workers compensation and lost productivity— for overweight, obesity, and physical inactivity exceeds \$3 billion;

WHEREAS, supporting the health of residents and the local workforce would decrease chronic disease and health care costs and increase productivity; and

NOW, THEREFORE, LET IT BE RESOLVED that the Lovettsville Town Council hereby recognized that the Town has a role in promoting and encouraging opportunity for physical activity and access to affordable, healthy foods so that residents can continue to enjoy a high quality of life and healthy, active, and productive lives. To that end, [name of city/town] adopts this Healthy Eating Active Living resolution:

I. Built Environment

BE IT FURTHER RESOLVED that the Town of Lovettsville should make every effort to:

- 1. Prioritize capital improvements projects to increase the opportunities for physical activity;

BE IT FURTHER RESOLVED that Lovettsville Staff shall work with HEAL Cities & Towns Campaign Staff to explore HEAL policies and to identify those policies that are suitable for the Town's unique local circumstances.
