### Staff Reports

### A. Report from the Project Manager

Project Manger Fellers reported that the Walker Pavilion won its first award from the Community Appearance Alliance. The awards luncheon will be held on March 14 at 11:00 a.m.

### B. Report from the Zoning Administrator

Zoning Administrator Hynes reported that Richmond American Homes will be building Section 4 of Lovettsville Town Center. She gave updates on two new development projects that will be coming forward (Lovettsville Glen and Cooper Run Estates), the Conditional Use Permit and text amendment for the Community Center, and modifications to the Zoning Ordinance to provide more diversity and density for housing options.

### C. Report from the Town Attorney

### D. Report from the Town Manager

Manager Markel noted the high number of water leaks in February due to fluctuating temperatures and aged equipment.

The April 10 Town Council meeting will be held at the Lovettsville Library in recognition of National Library Appreciation Week. Following the meeting at the Library, the Council will reconvene back at Town Hall for a budget work session.

### Action/Discussion Items

### A. Potomac Partnership

Councilwoman Carder presented this item. The Council is being asked to discuss developing a working relationship with the City of Brunswick, Maryland and to consider formally recognizing this relationship as the Potomac Partnership. Councilwoman Carder discussed the ways the two communities could work together to share resources and cross-promote businesses, organizations, and events. This is a great opportunity for the Town and City to complement one another and not duplicate efforts.

Zoning Administrator Hynes discussed the recent meeting of staff and elected officials from Brunswick and Lovettsville to discuss the Potomac Partnership and potential ways for the two communities to work together.

The Mayor and Council discussed common needs including a grocery store, a community calendar, economic opportunities, and shared equipment/resources.

Motion: I move that Town Council direct staff to begin the Potomac Partnership Process, including the following action items:

Action 1: Prepare a Resolution to be adopted at an upcoming Town Council Meeting.

Action 2: Invite the Brunswick City Council to attend a Lovettsville Council Meeting to witness the signing of the Potomac Partnership Resolution on behalf of the Town of Lovettsville.

Action 3: Accept the invitation by the Mayor of Brunswick to the Lovettsville Council to attend an upcoming Brunswick Council Meeting to witness the signing of the Potomac Partnership Resolution on behalf of the City of Brunswick.

### B. LVZA 2013-0005 Amendments to Fence Height Requirements (Public Hearing)

Mayor Zoldos suspended the regular meeting at 8:07 p.m. and opened the public hearing for LVZA 2013-0005 Amendments to Fence Height Requirements. Vice Mayor Senate read the Notice of Public Hearing (Attachment 1).

Zoning Administrator Hynes presented this item. The Council is being asked to consider an amendment to Section 4-6, Section 4-7 and Section 13 of the Town of Lovettsville Zoning Ordinance to modify fence requirements. Modifications includes the following: to define secondary front yard; to allow fence height to increase in the secondary front yard of a corner lot to four (4) feet; to allow fence height to increase on commercial property adjacent to residential property; to limit the use of temporary fence materials; and to amend the visibility requirements to meet Virginia Department of Transportation standards.

Mayor Zoldos called for questions from the Council and comments from the public. Molly Hafner asked if the fence requirements would apply to the proposed community garden at Quarter Branch Park. Zoning Administrator Hynes said the fence regulations would probably not apply to a garden. Hearing no further questions, Mayor Zoldos closed the public hearing at 8:20 p.m., opened the regular meeting, and called for a motion.

### C. LVRZ 2013-0002 Proffer Amendment for 5 North Berlin Pike (Public Hearing)

Mayor Zoldos opened the public hearing for LVRZ 2013-0002 Proffer Amendment for 5 North Berlin Pike at 8:26 p.m. Vice Mayor Senate read the Notice of Public Hearing (Attachment 1).

Zoning Administrator Hynes presented this item. The Council is being asked to consider a request from Malcolm and Pamela Baldwin to amend the approved proffers associated with the April 25, 2013 rezoning of the 0.74 acre parcel located at 5 North Berlin Pike from R-1 (Residential) to C-1 (Community Commercial). The Applicants are requesting an amendment to Proffer #5 to reduce the setback from the Route 287 right-of-way from 30 feet to 20 feet to address parking space needs. Staff noted that the requested 20 foot setback is still much greater than the C-1 front set back of 5 feet.

Pamela Baldwin said the preliminary concept for the co-op building is a "barn like" structure with a "country-store" look.

Zoning Administrator Hynes noted that staff concerns about the rear elevation of the building facing North Berlin Pike have been addressed with an additional proffer submitted by the Applicants. The proffer includes a minimum of two windows (real or simulated) with flower boxes, a door entry (real or simulated), a gable or dormers with windows, and outdoor lighting. Staff recommends approval of the Applicant's proffers.

Mayor Zoldos called for comments from the public. There were none. The Mayor closed the public hearing at 8:36 p.m., opened the regular meeting, and called for a motion.

Motion: I move to that the Lovettsville Town Council approve LVRZ 2013-0002: 5 North Berlin

Pike Proffer Amendment.

Mayor Zoldos called for discussion. Councilman McIntyre said he was glad to see the additional proffer to address the rear-elevation, which is something the Town has been working on with other commercial developments.

Pamela Baldwin said there has been a lot of discussion with the co-op Board about the kind of building they are considering. She provided copies of a preliminary drawing (Attachment 2) with different color schemes. In response to a question from Mayor Zoldos, Mrs. Baldwin said the design was not being proffered.

Mayor Zoldos noted the parallels to the Community Center elevations with regard to the Eastern gateway to the Town. He said he would like to see an actual design proffer for the co-op but understands this is a unique situation because the Applicants are working with a group of people. Malcolm Baldwin said they are depending on others to make this a viable project and they cannot proffer something that they cannot guarantee or afford.

### D. SCADA Upgrades for Water System

Project Manager Fellers presented this item. The Council is being asked to consider approving the Sherwood-Logan proposal for installation of the supervisory control and data acquisition (SCADA) design by CH2M Hill.

Project Manager Fellers introduced Brian Sumner, from CH2M Hill. Mr. Sumner discussed the limitations of the current hardware/software and the benefits of upgrading the system, including more automated features and reliability.

In response to questions from the Mayor and Council, Project Manager Fellers said the upgrades will provide a more robust system that is easier to maintain. Manager Markel said there are sufficient funds in the water fund reserve to cover the costs and that the system needs to be replaced at some point soon. Mr. Sumner said the new system will be more scalable and can be made accessible from remote locations.

Motion: I move that Town Council approve the Sherwood-Logan Proposal titled SCADA

System Upgrade for the Lovettsville Water Treatment and Distribution System dated November 25, 2013 for the amount of \$125,000 and approve the Division 16 proposal dated November 22, 2013 in the amount of \$25,000 plus a contingency of \$12,000 and authorize the Mayor or Town Manager to sign the necessary paperwork. I further

move that Town Council authorize staff to release Hill for the services during construction and follow-on services in order to provide support during the installation.

Tour to be taken from the Miscellaneous Donation Line Item in the FY 2014 Budget and direct the Town Manager to submit the necessary paper work to apply for a matching grant for the Western Loudoun Artists Studio Tour offered through the Virginia Commission for the Arts, along with supporting the Tour through the Town's

public communication outlets.

modified contract once in a form acceptable to the Town.
