# B. Town Center Update

Manager Markel said the Town has received a formal application from the developer for proffer amendments and rezoning for the commercial area. This would modify the plans that were approved by the Town Council in 2006. After withdrawing the proffer amendments that were proposed in 2012, the developer has resubmitted new plans, with the new concept design, and new proffers. The developer is proposing to reduce the total footprint of the commercial space from two buildings to one building and to add six single family residential lots in lieu of one of the commercial buildings. Manager Markel explained that this is what the developer has proposed and the application will still have to be fully reviewed by the Planning Commission and the Town Council. The application is currently going through staff review.

WHEREAS, collection and review of ordinances for incorporation into the proposed Town Code revealed that revisions were needed to the Subdivision Ordinance of Lovettsville, Virginia (2000) in order to bring it up to date to conform to state code amendments and changes in the law as well as to correct mistakes; and

WHEREAS, text proposed to become Chapter 30, Subdivisions, in the new Code was prepared and advertised for review and comment as LVSA 2014-0001 and was subject of a joint public hearing by the Town Council and Planning Commission on June 12, 2014 and the Planning Commission recommended approval of the text as amended; and

WHEREAS, the Town Council has determined that the ordinance, as amended, will facilitate implementation of the Comprehensive Plan and promote the orderly subdivision and development of property within the Town.

**NOW, THEREFORE, BE IT ORDAINED** that LVSA 2014-0001 repealing and reenacting the Subdivision Ordinance of Lovettsville, Virginia (2000), be approved as set forth in the text attached hereto. This ordinance shall be effective immediately.

WHEREAS, collection and review of ordinances for incorporation into the proposed Town Code revealed that revisions were needed to the Zoning Ordinance of Lovettsville, Virginia in order to bring it up to date to conform to state code amendments and changes in the law as well as to correct mistakes; and

WHEREAS, text proposed to become Chapter 42, Zoning, in the new Code was prepared and advertised for review and comment as LVZA 2014-0002 and was subject of a joint public hearing by the Town Council and Planning Commission on June 12, 2014 and the Planning Commission recommended approval of the text as amended; and

WHEREAS, the Town Council has determined that the ordinance, as amended, will facilitate implementation of the Comprehensive Plan, is consistent with good zoning practice and will promote the health, safety and welfare of the Town and its citizens.

**NOW, THEREFORE, BE IT ORDAINED** that LVZA 2014-0002 repealing and reenacting the Zoning Ordinance of Lovettsville, Virginia, be approved as set forth in the text attached hereto. This ordinance shall be effective immediately.

ORDINANCE NO. 2014-06-0003: ADOPTING AND ENACTING A NEW CODE FOR THE TOWN OF LOVETTSVILLE, VIRGINIA; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN; PROVIDING A PENALTY FOR THE VIOLATION THEREOF; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE; AND PROVIDING WHEN SUCH CODE AND THIS ORDINANCE SHALL BECOME EFFECTIVE.

MOTION: Senate SECOND: Allar

NOW, THEREFORE, BE IT ORDAINED by the Lovettsville Town Council that:

Section 1. The Code entitled "Town Code of Lovettsville, Virginia," published by Municipal Code Corporation, consisting of chapters 1 through 42, each inclusive, is adopted.

Section 2. All ordinances of a general and permanent nature enacted on or before February 27, 2014, and not included in the Code or recognized and continued in force by reference therein, are repealed.

Section 3. The repeal provided for in section 2 hereof shall not be construed to revive any ordinance or part thereof that has been repealed by a subsequent ordinance that is repealed by this ordinance.

Section 4. (a) The penalty provided by this section, unless another penalty is expressly provided, shall apply to the amendment of any Code section, whether or not such penalty is reenacted in the amendatory ordinance.

- (b) In this section the term "violation of the Code" means any of the following:
- (1) Doing an act that is prohibited or made or declared unlawful, an offense, a violation or a misdemeanor by ordinance or by rule or regulation authorized by ordinance.
- (2) Failure to perform an act that is required to be performed by ordinance or by rule or regulation authorized by ordinance.
- (3) Failure to perform an act if the failure is prohibited or is made or declared unlawful, an offense, a violation or a misdemeanor by ordinance or by rule or regulation authorized by ordinance.
- (c) In this section, the term "violation of the Code" does not include the failure of a town officer or town employee to perform an official duty unless it is specifically provided that the failure to perform the duty is to be punished as provided in this section.
- (d) Except as otherwise provided by law or ordinance, violations of the Code shall be a class 1 misdemeanor. No penalty shall exceed the penalty prescribed by general law for a like offense and such penalty shall not be any less than such penalty. Persons convicted of a violation of this Code shall be punished as follows:
  - (1) For a class 1 misdemeanor, by the penalty provided in state law for a class 1 misdemeanor.
  - (2) For a class 2 misdemeanor, by the penalty provided in state law for a class 2 misdemeanor.
  - (3) For a class 3 misdemeanor, by the penalty provided in state law for a class 3 misdemeanor.
  - (4) For class 4 misdemeanors, by the penalty provided in state law for a class 4 misdemeanor.
  - (e) Except as otherwise provided by law or ordinance:
  - (1) With respect to violations of the Code that are continuous with respect to time, each day that the violation continues is a separate offense.

- (2) With respect to violations of the Code that are not continuous with respect to time, each act constitutes a separate offense.
- (3) All imprisonment imposed for a violation of the Code shall be in the county jail.
- (f) Any violation of the Code by any officer, agent or other person acting for or employed by any corporation or unincorporated association or organization, while acting within the scope of his office or employment, shall in every case also be deemed to be a violation by such corporation, association or organization.
- (g) Any officer, agent or other person acting for or employed by any corporation or unincorporated association or organization shall be subject and liable to punishment, as well as such corporation or unincorporated association or organization, for the violation by it of any provision of the Code, where such violation was the act or omission or the result of the act, omission or order of any such person.
- (h) The imposition of a penalty does not prevent suspension or revocation of a license, permit or franchise or other administrative sanctions.
- (i) Violations of the Code that are continuous with respect to time are a public nuisance and may be abated by injunctive or other equitable relief. The imposition of a penalty does not prevent injunctive relief.
- Section 5. Additions or amendments to the Code when passed in such form as to indicate an intent to make the same a part of the Code shall be deemed to be incorporated in the Code, so that reference to the Code includes the additions and amendments.
- Section 6. Ordinances adopted after February 27, 2014, that amend or refer to ordinances that have been codified in the Code shall be construed as if they amend or refer to like provisions of the Code.

WHEREAS, the Town contracted with Municipal and Financial Services Group to conduct a thorough evaluation of the Town's utility finances and expenses to develop a multi-year rate plan to ensure the Town's utility system is fiscally strong and able to provide its users with high quality water and sanitary sewer service; and

WHEREAS, the Town Council has determined it is fair and reasonable to increase the user rates 3 percent for water service and 6 percent for sewer service for fiscal year 2015.

WHEREAS, notice of the proposed changes has been given in accordance with the requirements of Virginia Code Section 15.2-107.

NOW, THEREFORE, BE IT ORDAINED that the Town's Schedule of Fees. be amended as set forth in the schedule attached hereto. This ordinance shall be effective after the 30<sup>th</sup> day of June, 2014.

Ordinance 2014-06-0005: APPROVE BUDGET AND CIP, ADOPT TAX RATES AND MAKE APPROPRIATIONS FOR FISCAL YEAR ENDING JUNE 30, 2015

WHEREAS, the budget, capital improvement plan (CIP), and tax rates for the fiscal year ending June 30, 2015, have been prepared and reviewed by the Town Council; and

WHEREAS, a brief synopsis of the proposed budget and CIP and notice of a public hearing to be held in the Town office on May 22, 2014 at 7:30p.m. were published in the public notices section of the Purcellville Gazette on May 9, 2014; and

WHEREAS, a public hearing was in fact held at the time and place advertised at which citizens had the right to attend and state their views on the budget and tax rates.

IT IS ACCORDINGLY ORDAINED by the Town Council of the Town of Lovettsville as follows:

- 1. The proposed budget and CIP are approved as presented.
- 2. Appropriations are hereby made for the fiscal year ending June 30, 2015, in the amounts shown to the categories and accounts therein for the general and utility funds and Frye Court Service District fund.
- 3. All outstanding operating encumbrances at June 30, 2014 are hereby reappropriated for the 2015 fiscal year to the same department and account for which they are encumbered in the previous year.
- 4. At the close of the fiscal year, all unencumbered appropriations lapse for budget items other than any capital projects and grants.
- 5. The tax rates and license fees for FY 2015 are hereby fixed at the levels shown in the attached schedule.
- 6. Water and Sewer rates shall be set as provided in the Town's Schedule of Fees, as amended by ordinance approved immediately prior hereto.
- 7. The tax rate for FY 2015 for the Frye Court Service District shall be fixed at \$0.275 per one hundred dollars (\$100.00) of assessed value for taxable real estate (exclusive of improvements).
- 8. Land use charges imposed as provided in the schedule of fees hereto attached, adopted by ordinance.

## Resolution 2014-06-0006: Proclamation in Honor of Councilman Jack Burden
