#### D. Report from the Town Manager

Manager Palko report that health care cost are going up 9%. He is working with staff on input for the budget and will be soliciting additional guidance from the Town Council as he begins preparing the draft budget.

#### Action Items

#### A. License Agreement for Storm Pond

Project Manager Fellers presented this item. The Council is being asked to approve the License Agreement with Loudoun County to share the future storm pond built for the new Community Center and allow the Town to install a temporary storm discharge until the pond is built.

Proiect Manager Fellers responded to questions from the Council regarding the budget, time frame, and technical aspects of the agreement. She noted the "Pardon our Dust" meeting for the East Broadway Project will be held on March 18 from 7:00-8:30 p.m. at the Community Center. Town staff and the contractors will meet with residents to explain the process and what they will see. The Town Council will be receiving detailed reports from the inspection team on a regular basis.

Motion: I move that Town Council authorize the Mayor to sign the License Agreement detailing the terms and conditions to permit the Town to share the County owned Lovettsville Community Center future storm pond and permit the Town to install a temporary storm water discharge line on the edge of the ball field as soon as possible.

# B. LVCU 2015-0001 Conditional Use Permit for Veterinary Clinic at 2 E. Pennsylvania Avenue Mayor Zoldos opened the public hearing for LVCU 2015-0001 at 7:53 p.m.

Zoning Administrator Bateman presented this item. The Council is being asked to consider a Conditional Use Permit for a veterinary clinic at 2 E. Pennsylvania Ave. He noted the draft Ordinance that had been prepared for the Council's consideration and said he recommended modifying the timeframe for Condition 2 from six months to two years based on further research he had done. Mr. Bateman further noted where the Planning Commission's recommendations deviated from staff recommendations including the number of dogs that could be kept overnight for observation, the size of other animals that can be treated on the site, and clarification regarding expansion of the facilities. He said there are additional provisions in the Zoning Ordinance that could address any potential noise issues.

In response to questions from the Council, Dr. Knode stated:

- She does not intend to see horses at the clinic; however, imposing a pound restriction limits the type of animals she can see, such as sheep and goats.
- The Town Manager can contact her directly if there is a noise problem.
- She cannot have a restriction on the number of animals that need to be hospitalized and still do business. In 20 years as a veterinarian, she has never seen limitations on the number of patients a clinic can see or hospitalize other than the limits imposed by the actual size of the facility. She is not kenneling or boarding animals, this is only for the hospitalization of sick animals.
- She cannot limit the amount of time an animal can be kept at the clinic; it depends on the animal's medical needs.
- She is regulated by the Virginia Board of Veterinary Medicine and she will provide a copy of this as required by the Conditional Use Permit.

Mayor Zoldos called for comments from the public. The applicant, Ann George, 13620 S. Berlin Pike, said this is a wonderful thing for the Town. It brings a service that many residents need and it brings people and jobs to the Town.

Hearing no further public comment, Mayor Zoldos closed the public hearing at 8:10 p.m. and called for a motion.

Motion: I move to adopt Ordinance No. 2015-02-0001 to approve the request from property owners Fred L. George III and Anne D. George for a Conditional Use Permit (CUP) to establish a veterinary hospital on their property at 2 East Pennsylvania Avenue, subject to the conditions recommended by the Planning Commission on February 4, 2015, which the Council deems necessary for the protection of the general welfare and individual property rights, and to ensure compliance with the intent and objectives of the zoning ordinance.

utilities), committee structure, and public input. The kickoff meeting will be held in March and the anticipated timeframe for completion is six to nine months. He invited the Council Members to participate in the process or to provide input.

# D. Adoption of Official Zoning Map

Zoning Administrator Bateman presented this item. Mr. Bateman said he has found no record that the Council has ever adopted an Official Zoning Map of the Town. He is asking the Council to officially refer this to the Planning Commission to conduct a public hearing and take action on the Draft Zoning District Map (Attachment 1).

Commission for its recommendation on adopting the map as the Official Zoning Map

of the Town of Lovettsville (Article 14 of Chapter 42 of the Town Code).

## F. SCADA Funding

Manager Palko said he is requesting a budget line item transfer to fully fund the development and implementation of the Supervisory Control and Data Acquisition (SCADA) system for the Town's water facilities. On February 27, 2014 the Council approved the motion to fund the SCADA implementation in FY 2014. He noted that \$100,000 had been budgeted for that program, but \$22,000 was used for the design phase. The funding request had been approved in the text version of the budget, but it was left out of the actual budget line item. To move forward with the implementation phase, Manager Palko is requesting that the Council transfer \$100,000 from the water line replacement budget line item across FY 2015 and FY 2016.

Motion: I move to approve and authorize the Town Manager to transfer \$100,000 from the

Water Line Replacement Project to fully fund the implementation of the SCADA System. In the FY 16 Budget, the Town Manager will budget the required remaining amount for the Water Line Replacement Project associated with the East Broadway

Sidewalks Phase 1 Project.
