## B. Water and Sewer Inspection Program

Town Engineer Fellers presented this item. The Council is being asked to review and approve Water and Sewer Inspection Fees. Staff recommends using a linear foot charge to calculate water/sewer main inspection fees based on the method used by Leesburg and Loudoun Water; a flat rate of \$150 per connection for water/sewer lateral inspection fees; and approximately \$8,000 for water/sewer record drawing fees, pending final approval the Town's contractor. Staff responded to questions from the Council regarding the impact on the Utility Department staff, contractor support, and proposed fees.

Motion: I move that Town Council select the recommended fee formulas and direct staff to

add these fees to a draft Schedule of Fees and bring forward for public hearing and to

Town Council for approval in conjunction with other planned modifications upcoming.

#### D. Election of Vice Mayor

Mayor Zoldos reviewed the procedures based on the Code of Virginia, the Town Charter, the Town Council Rules and Procedures, and Robert's Rules of Order. He discussed the process for nominations, voting, and election of the Vice Mayor. The Mayor then opened nominations for the position of Vice Mayor.

- Councilwoman Allar nominated Councilwoman Carder.
- Councilman Gentile nominated Councilman McIntyre.

Mayor Zoldos called for any additional nominations. There were none. Mayor Zoldos closed the nominations and opened the meeting for discussion and asked two candidates to speak. Councilwoman Carder and Councilman McIntyre spoke about their service to the Town and why they would like to serve as Vice Mayor. Mayor Zoldos called for additional comments. Hearing none, he called for a roll call vote:

Mayor Zoldos said here was a majority vote for Councilwoman Carder, who received four votes. The Mayor congratulated Councilwoman Carder and thanked Councilman McIntyre for offering to serve as Vice Mayor.

Mayor Zoldos noted that the Town Council's Rules and Regulations need to be reapproved every two years and the Council will take this up in August.

Councilman Senate said he has enjoyed serving as Vice Mayor. He noted that both candidates are very involved in the community so it was hard to vote for one over the other. Mayor Zoldos thanked Councilman Senate for serving as Vice Mayor the past four years.

## E. Town Council Committee Structures

Mayor Zoldos presented this item. The Council is being asked to review the committee structure to reduce the number of committees and to improve their focus. Mayor Zoldos and the Town Manager gave a presentation on the current committees and proposed changes. The proposed structure includes the

Each committee/subcommittee includes a Chair, Vice Chair, Council Member, Planning Commissioner, and Resident. Following discussion, Mayor Zoldos asked the Council Members to participate in five committees/subcommittees and to submit their requests to the Town Manager.

action as appropriate.

I further move that the Town Manager be authorized to execute the settlement agreement on the Town's behalf after approval for form and consistency with this authority by the

Town Attorney.
