

Town Council Minutes of the August 11, 2016 Regular Meeting

Presentations

Laura Lieberman and Mark Lenko gave a presentation on Keep Loudoun Beautiful and asked the Town Council to participate in April 2017.

Comments from the Public

Mayor Zoldos called for comments from the public. There were none.

A. Loudoun County Sheriff's Office
