Action/Discussion Items

A. Public Hearing - FY 18 Budget

Councilwoman Allar read the notice of public hearing. Vice Mayor Carder opened the public hearing at 7:42 p.m. and called for comments from the public. Councilwoman Allar read the rules for public comment.

Chris Hornbaker, 15 Black Forest Lane, spoke about the budget, which he has tracked for the past four years. He discussed the Utility Fund and General Fund and likened them to two different pants' pockets. He understands wanting to fast-track some of the capital improvement items and he understands the vision of the Town, which he aligns with. However, now \$65,000 more dollars are being taken from the Utility Fund to the General Fund, and water and sewer rates have gone up 30% and counting. He said his property assessments have gone up so the real dollars in this pocket (referring to the General Fund) have increased and the real dollars in the Utility Fund have increased and will continue to increase. He spoke about diversification and said he would like to see some transparency if there is a long-term plan to increase the new trash fee that is being proposed in the Town Manager's budget beyond 10%.

Following Mr. Hornbaker's comments, a discussion ensued regarding the Utility Fund rate increases and how that information was communicated to the public.

Mayor Zoldos arrived at 7:52 p.m. and proceeded to take over chairing the meeting. He called for additional comments from the public. Hearing none, he closed the public hearing at 7:53 p.m.

Closed Session

Mayor Zoldos announced that the Council would be convening in closed session to discuss a personnel matter. Vice Mayor Carder made the following motion:

Code section 2.2-3711A1 for discussion, consideration, or interviews of prospective candidates for employment; assignment, appointment, promotion, performance, demotion, salaries, disciplining, or resignation of specific public officers, appointees, or employees of any public body; for discussion of possible resignation by specific public officers, appointees or employees and options for reconfiguring the staffing of affected operations if such resignation occurs; and thereafter reconvene in open

session for action as appropriate.

Mayor Zoldos read a statement from Chairman McDonough which stated that this is the first time in the Town's history that all seven Commissioners have been certified by the Virginia's Land Use Education program.
