Action/Discussion Items

A. Work Session on Commercial and Industrial Zoning Districts

Mr. Bateman presented this item. The Commissioners continued to review Article VII (Commercial and Industrial Zoning Districts) of the Zoning Ordinance in order to amend the uses permitted by-right and with a conditional use permit in the Town's commercial and industrial zoning districts and to add performance standards and definitions for specific uses, as necessary. A discussion ensued regarding the following uses in the commercial and industrial zoning districts:

• Personal Service – auto repair shops, banks and financial institutions with and without drive-through windows, child care centers, dry cleaners (transfer facility only), emergency care facility, libraries, funeral home, light vehicle repair shops, medical care facility (outpatient only), medical clinics,

medical and health services, personal services, publishing and printing establishments, and veterinary hospital.

- Retail Sales and Services, including those with outdoor storage/display.
- Institutional/Assembly churches/places of worship (religious facilities); colleges and universities; convention and meeting facilities; corporate center; fraternal clubs, lodges, and community buildings for use by nonprofits organizations; government buildings and facilities; libraries; museum and cultural centers; public parking lot; post office; and schools (technical, trade, vocation, business).
- Recreation/Entertainment country club/golf course, indoor recreation facilities, movie theatre, performing arts center, public park, performing arts center, and commercial recreational facilities.
- Lodging bed and breakfast and country inns.
- Creative/Artistic art kilns and foundries; communications and broadcast studio; dance, music and/or fitness studio (fitness center); and studio space for artists, crafters, or writers (artist galleries and studios).
- Office administrative, business, and professional offices; medical and dental offices; professional and government offices; and technology offices.
- Utility public utility facilities and wireless communications equipment.
- Residential/Accessory construction and/or sales trailer and mixed-use commercial dwellings.
- Industrial any structure greater than 10,000 square feet; blacksmith shop, welding or machine shops excluding 40-ton rated capacity and drop hammers; contractors offices without outdoor storage yards; contractor office with indoor and outdoor storage; furniture and cabinet making shops; furniture and cabinet making shops (indoor only); manufacturing and assembling under 6,000 square feet; and manufacturing, processing, and assembling of goods without outdoor storage/display; and microbrewery.

Zoning Administrator Bateman noted the changes discussed and said he would bring back a revised version of uses and definitions.
