

Town Council Minutes of the September 14, 2017 Regular Meeting and Public Hearing

B. Selection of Engineers for the E. Broad Way Phase 2A Improvements Project

Ms. Fellers presented this item. The Council is being asked to select engineers for design and inspection/construction management support for East Broad Way Phase 2A and to approve a scope of services for the initial design work. The selection committee is recommending awarding the contract to Pennoni; however, the scope is higher than what has been budgeted. Staff is asking the Council to select the engineer and to authorize the Town Manager to negotiate the scope and come back to the Council with a funding plan. Mr. Finz said there is \$150,000 available from the County for this project and that the Town many need to use some of its reserve funds to complete the engineering. He will come back to the Council with a recommendation after he has completed the negotiation. Vice Mayor Carder made the following motion:

Motion: I move that Town Council select Pennoni to complete the design engineering for E.

Broad Way Phase 2A Improvements Project and authorize the Town Manager to negotiate with the Engineering Firm to finalize the Scope of Services and present a plan for funding this work. I further move to authorize the Town Manager to where practicable, use outside grant application development services with a budget not to

exceed \$10,000 to support funding applications for the project.

C. Detailed Review and Analysis of FY17 and FY18 Five-Year CIP and Capital Budgets

The Council is being asked to consider changes to the FY18 General and Utility Fund CIP and Capital budgets that more accurately reflect projects, project completion dates, and project budgets. Mr. Finz said he is requesting approval from the Council to proceed with conducting a public hearing since the proposed FY 18 budget increase is more than one percent of the total budget. Ms. Fellers noted that the increase in the FY 18 budget is due to carryover from projects that were not fully completed in FY 17. Councilwoman Allar made the following motion:

to the FY18 Five Year CIP and Capital Budgets to be held on October 12, 2017.

Resolution 2017-09-0001: APPROVE FIRST BOND REDUCTION FOR PUBLIC IMPROVEMENTS IN LOVETTSVILLE GLEN SUBDIVISION

MOTION: FONTAINE

SECOND: MCINTYRE

WHEREAS, H2 Land Company on behalf of Nighthawk Investments, LLC (hereinafter "the applicant") has received approval of subdivision construction drawings for the Lovettsville Glen Subdivision and commenced construction of site improvements in accordance with said approval; and

WHEREAS, the Lovettsville Town Council on January 19, 2017 approved the performance agreement dated December 23, 2016 provided by the applicant and Irrevocable Letter of Credit No. 13002349-8003 issued by MVB Bank, Inc (surety) guaranteeing the installation of required public improvements within the Lovettsville Glen Subdivision pursuant to Section 30-34 of the Subdivision Ordinance (Chapter 30 of the Town Code); and

WHEREAS, pursuant to Section 30-35 of the Subdivision Ordinance and §15.2-2245 of the Code of Virginia, the applicant has submitted a request for a first reduction in the amount of the performance bond based upon the extent of public improvements installed, as documented on the bond reduction forms prepared by the applicant dated August 21, 2017; and

WHEREAS, based upon inspection by the Town's engineering consultant, Christopher Consultants, the Town supports a reduction in the bond from the current bond amount of \$809,195.00 to the new bond amount of \$438,944.40.

NOW, THEREFORE, BE IT RESOLVED that the Lovettsville Town Council hereby approves the recommendation of the Town's engineering consultant referenced above, and authorizes the Mayor and Town Attorney to approve the reduction as appropriate when tendered in a form approved by the Town Attorney.

Resolution 2017-09-002:

APPROVE PROCESS FOR CIVIL ENFORCEMENT OF ZONING ORDINANCE VIOLATIONS AND AUTHORIZE ENFORCEMENT ACTION FOR FENCE VIOLATIONS AT 14 S. LOUDOUN STREET

MOTION:

FONTAINE

SECOND:

WHEREAS, Town policy customarily relies upon voluntary enforcement measures to abate violations of the zoning ordinance when they are discovered or have been brought to the attention of the Town Council or Zoning Administrator, without need to resort to coercive measures authorized by law; and

WHEREAS, recent experience with failing to obtain voluntary compliance prompted the Interim Town Manager to seek a report from the Town Attorney and Zoning Administrator regarding options available to the Town, recommendations regarding use of such options, and development and update of forms and procedures for implementing a formal program of zoning enforcement via implementation of the civil penalty program authorized by Va. Code section 15.2-2209;

WHEREAS, the civil penalty enforcement program foresees abating violations by stepby-step proceedings according to the following typical sequence after receipt of a complaint or report of zoning violation:

- 1. Informal contact with the person creating or maintaining the violation, to alert him as to the ordinance violation and measures necessary to bring the property into compliance with the zoning ordinance.
- 2. Letter memorializing informal contact, confirming violation and urging cooperative effort to remedy the violation.
- 3. Notice of violation (NOV) and corrective order: Formal notice of violation and order setting a reasonable time period in which prescribed remedial action must be taken to abate the violation, noting prospect of civil penalties or other enforcement action if not corrected and noting opportunity to appeal to BZA.
- 4. Following failure to correct within time prescribed and failure to appeal to BZA or resolution of the BZA appeal in favor of the Town, issuance of Civil Penalty Ticket(s). First offense \$200; subsequent offenses \$500, not to be charged any more frequently than once every 10 days and not to exceed \$5,000 in total fines.
- Following failure to cure violation after issuance of three tickets, Town Attorney
 enforcement letter noting referral of file and giving a date certain by which fines must be
 paid and violation cured, or enforcement proceedings will be filed in General District
 Court.
- 6. If violation remains uncorrected and tickets remain unpaid on the date specified in the Town Attorney enforcement letter, enforcement of unpaid tickets via summons and warrant in debt in General District Court. Order of Abatement can be obtained from



- Court if the violation remains uncorrected, as well as judgment for the cumulative amount of the tickets, filing fees and up to 20% attorney's fees.
- 7. Non-compliance with the Order of Abatement, which sets a time period no greater than six months for completion, is enforceable by the Court's contempt powers and Va. Code section 15.2-2209 also makes each day of violation of the order a separate offense, subject to further fines.

NOW, THEREFORE, BE IT RESOLVED that the Lovettsville Town Council hereby approves the recommendations of the Zoning Administrator for implementing a civil penalty program for zoning violations, as outlined above, and specifically authorizes initiating enforcement action in accordance with the program to abate the fence violations existing at 14 S. Loudoun Street.
